### MOTIONS AND RESOLUTIONS

- HB 1167 (Intent to Reconsider Vote by Which Lost) revise provisions regarding confidential communications between a student and certain school employees. (House Education Engrossed)
- HCR 6016 (Deferred from 25<sup>th</sup> LD) Supporting the efforts of William "Bill" Casper as the South Dakota state chairman of the State Funeral for World War II Veterans in his efforts to petition President Donald J. Trump to hold a state funeral for World War II veterans. (Introduced)

- HB 1140 provide for a regular review of parenting guidelines. (House Judiciary Engrossed)

### SECOND READING OF HOUSE BILLS AND JOINT RESOLUTIONS

- HB 1218 require responses and reporting regarding the testing, assessment, evaluation, or observation of students. (House Education Engrossed)
- HB 1179 (Removed from Consent Calendar) authorize series limited liability companies. (Introduced)
- HB 1004 (Deferred from 25<sup>th</sup> LD) provide for the defense of laws by the Legislature. (House State Affairs Engrossed)
- HB 1226 (Deferred from 25<sup>th</sup> LD) revise certain provisions regarding local referendums. (House State Affairs Engrossed)
- HB 1100 (Deferred from 25<sup>th</sup> LD) make an appropriation to begin the research and development of a new bioprocessing facility and to declare an emergency. (Joint Appropriations Engrossed)

- HB 1068 (Deferred from 25<sup>th</sup> LD) include out-of-state convictions for the basis of an enhanced penalty for the crime of stalking. (Introduced) (PJPCE)
- HB 1172 require the annual submission of a zero-based budget from certain departments or budget units. (Introduced)

SECOND READING OF SENATE BILLS AND JOINT RESOLUTIONS

- SB 52 (Deferred from 25<sup>th</sup> LD) create a state seal specialty plate emblem. (Introduced)
