MOTIONS AND RESOLUTIONS

- SJR 503 (Intent to Reconsider by which lost) Rescinding House Joint Resolutions calling for a constitutional convention for the sole purpose of changing the Constitution of the United States. (Introduced)
- SCR 603 (Deferred from 26th LD) Recognizing the importance of gun safety. (Senate Health and Human Services Engrossed)

SECOND READING OF CONSENT CALENDAR ITEMS

- SB 174 revise the purposes for which a school district's capital outlay fund may be used. (Introduced)
- HB 1109 revise the Uniform Limited Liability Company Act. (Introduced)
- HB 1131 prohibit the use of misleading identification for telephonic communications. (Introduced)

SECOND READING OF SENATE BILLS AND JOINT RESOLUTIONS

- SB 117 require the Department of Education to establish certain programs for children who are deaf and hard-of-hearing. (Introduced) (Fiscal Note)
- SB 96 prohibit the denial of benefits based solely on a controlled substance felony. (Introduced) (Fiscal Note)

- SB 66 (Deferred from 26th LD) provide for the creation and funding of Oceti Sakowin community-based schools. (Senate Education Engrossed)
- SB 142 establish certain restrictions regarding the state subsidized dual credit program. (Senate Appropriations Engrossed)
- SB 144 establish certain restrictions regarding participation in the state subsidized dual credit program for certain students. (Senate Appropriations Engrossed)
- SB 180 repeal and revise certain provisions regarding the petition circulation process. (Senate Local Government Engrossed)
- SB 156 repeal provisions regarding the South Dakota Veterans Commission. (Introduced)

SECOND READING OF HOUSE BILLS AND JOINT RESOLUTIONS

- HB 1025 (Deferred from 25th LD) (JR 5-17 with pending amendment) revise certain provisions regarding plugging and performance bonds for oil and gas wells. (Introduced)
- HB 1008 legalize the growth, production, and transportation of industrial hemp in the state, and to declare an emergency. (House Agriculture and Natural Resources Engrossed) (PJPCE)
