SECOND READING OF CONSENT CALENDAR ITEMS

- HB 1110 provide for a uniform template to be used by each state agency in the conduct of performance management reviews. (House Government Operations and Audit Engrossed)
- HB 1259 clarify provisions regarding the discretionary formula for determining the assessed value of property for tax purposes. (House Taxation Engrossed)
- HB 1264 revise provisions regarding the procurement of public improvements. (House Local Government Engrossed)
- HB 1154 revise certain provisions regarding motor vehicle license plates. (House Transportation Engrossed)

- HB 1238 permit modification of the term of a perpetual conservation easement after the death of the grantor. (House Agriculture and Natural Resources Engrossed)
- HB 1263 revise certain provisions regarding the dates on which certain school district elections may be held. (House State Affairs Engrossed)
- HB 1248 revise the motor vehicle license fee for certain older trucks. (House Transportation Engrossed)
- HJR 5003 Proposing and submitting to the electors at the next general election, an amendment to Article XII of the Constitution of the State of South Dakota, relating to the creation of the property tax relief trust fund and to provide for the transfer of unobligated cash. (House Appropriations Engrossed)
- HB 1245 revise certain provisions regarding the voting rights of felony offenders. (House State Affairs Engrossed)
- HB 1088 create a penalty for violation of a vulnerable adult protection order and to revise certain provisions regarding protection orders. (House Judiciary Engrossed) (PJPCE)
- HB 1212 add certain persons to the list of mandatory reporters of suspected child abuse or neglect. (House Judiciary Engrossed)
