8 **MOTIONS AND RESOLUTIONS**

9 **SCR 603:** A CONCURRENT RESOLUTION, Recognizing the importance of gun safety.

10 Was read the second time.

11 Sen. Nesiba moved that **SCR 603** as found on page 115 of the Senate Journal be adopted as
12 amended on page 301 of the Senate Journal.

13 Sen. Stalzer moved that **SCR 603** be amended as follows:

14 SCR603D

15 On the Senate Health and Human Services bill, delete everything after the title and insert:

16 "

17 WHEREAS, since 1903, the first year for which data was available, the per capita rate of
18 accidental gun deaths has decreased 95 percent, from 3.1 to 0.14 deaths per 100,000 people; and

19 WHEREAS, in 2018, the number of accidental gun deaths was 458--the lowest since at least
20 1903--and a record low of 0.14 deaths per 100,000 people; and

21 WHEREAS, during the past 25 years, the number of accidental gun deaths has decreased by
22 more than 66 percent while, at the same time, Americans acquired more than 200 million new guns
23 and today own approximately 407 million guns -- an all-time ownership high; and

24 WHEREAS, guns are involved in only 0.27 percent of all accidental deaths and only 1.4
25 percent of all accidental deaths among children; and

26 WHEREAS, the best way to decrease all accidents is through voluntary education efforts
27 such as the National Rifle Association's safety programs, which are conducted by nearly 116,000
28 National Rifle Association Certified Instructors and Range Safety Officers nationwide, and which
29 reach more than 1 million participants annually; and

30 WHEREAS, multiple National Rifle Association programs that teach children about gun safety
31 are offered each year through civic groups such as the Boy Scouts of America, the Jaycees, and the
32 American Legion, as well as through public and private schools; and

33 WHEREAS, the National Rifle Association's Eddie Eagle GunSafe program, which since 1988
34 has been used by 28,000 teachers and law enforcement officers to reach more than 31 million

1 children from pre-school through the third grade, teaches children that if they see a gun, they should
2 not touch it and they should tell an adult; and

3 WHEREAS, the National Rifle Association's Law Enforcement Division has trained over
4 60,000 law enforcement firearms instructors since its inception and currently has more than 13,000
5 active, certified, law enforcement firearms instructors conducting firearms training for local, state
6 ,and federal law enforcement agencies, as well as for the military; and

7 WHEREAS, deaths resulting from motor vehicle accidents outnumber accidental gun deaths
8 by 83 to 1; and

9 WHEREAS, gun control supporters are calling for gun manufacturers to be subjected to
10 consumer product regulations that are designed to result in the banning of handguns and other
11 weapons;

12 NOW, THEREFORE, BE IT RESOLVED, by the Senate of the Ninety-Fifth Legislature of the
13 State of South Dakota, the House of Representatives concurring therein, that all owners and users
14 of guns commit to observing and abiding by safe handling and storage practices, and that they avail
15 themselves of training and practice opportunities so that safety improvements continue to be
16 realized.
