- SB 1 (Removed from Consent Calendar) provide for the use of electronic communication in the involuntary commitment process and to declare an emergency. (Introduced)
- SB 160 (Removed from Consent Calendar) authorize the construction and operation of a nursing home facility in Moody County, South Dakota, and to declare an emergency. (Introduced)
- SB 97 (Removed from Consent Calendar) title vehicles older than thirty years with no existing record. (Introduced)
- SB 128 (Deferred from 31st LD) revise entities who may contribute to a political committee. (Senate State Affairs Engrossed)
- SB 186 (Deferred from 31st LD) revise certain leave policies for state employees. (House State Affairs Engrossed)
- SB 161 (Deferred from 31st LD) exempt certain real property from the special maintenance fee levy. (Introduced)
- SB 4 (Deferred from 31st LD) provide for the designation of an appropriate regional facility by the Department of Social Services. (Introduced)

- SB 155 (Deferred from 31st LD) provide for step therapy protocol regarding certain prescription drugs. (Senate State Affairs Engrossed)
- SB 24 (Deferred from 31st LD) revise the fees for pesticide registration, private applicator licenses, commercial applicator licenses, and pesticide dealer licenses. (Senate Appropriations Engrossed)
- SB 150 (Deferred from 31st LD) revise nonresident waterfowl licensure. (Senate Engrossed)
- SB 21 (Deferred from 31st LD) authorize temporary variable speed limits on state highways under certain circumstances. (Introduced) (Fiscal Note)
- SB 113 (Deferred from 31st LD) revise certain provisions regarding instruction permits and restricted minor's driving permits. (Senate Engrossed)
- SB 137 (Deferred from 31st LD) revise provisions for repair, replacement, and construction of sidewalks within a municipality. (Senate Engrossed)
- SB 183 (Deferred from 31st LD) revise the signature requirements for the nominating petitions for certain elected offices. (Senate Engrossed)
- SB 180 repeal and revise certain provisions regarding the petition circulation process. (House Local Government Engrossed)
- SB 41 authorize the Board of Regents to contract for the construction of a facilities building at the University of South Dakota and to make an appropriation therefor. (Introduced)
- SB 42 authorize the Board of Regents to demolish three storage structures and contract for the construction of a grounds facility at the University of South Dakota and to make an appropriation therefor. (Introduced)
- SB 43 authorize the South Dakota Building Authority to issue revenue bonds to provide for maintenance and repair on facilities controlled by the Board of Regents and to provide appropriation therefor. (Introduced)
- SB 39 establish the Jobs for South Dakota's Graduates program and the special donation fund. (Introduced)
- SB 26 increase for one year the assessment of liquidated court costs and to revise the disposition of the funds collected. (Senate Engrossed)
- SB 33 authorize the Department of the Military to construct a storage building located in Brown County, to make an appropriation therefor, and to declare an emergency. (Introduced)
- SB 35 revise the appropriation for the State Veterans' Cemetery and to declare an emergency. (Introduced)
- SB 119 revise certain provisions regarding private placement insurance. (Introduced)
