- HB 1092 provide for an assumption of risk by any person engaged in off-road vehicle activity and to limit the liability of the renters of off-road vehicles under certain circumstances. (Senate Judiciary Engrossed)
- HB 1206 revise certain provisions regarding the commitment of a delinquent child to the Department of Corrections. (Senate Judiciary Engrossed)
- HB 1199 revise civil liability for riot and incitement to riot. (Senate Commerce and Energy Engrossed)
- HB 1044 make an appropriation to the Board of Regents to fund the development of the Cyber Incubator and Entrepreneurial Center at Dakota State University and to declare an emergency. (Introduced)
- HB 1045 authorize the Board of Regents to contract for the design, renovation of, and addition to, the E.Y. Berry Library on the campus of Black Hills State University and to make an appropriation therefor. (Joint Appropriations Engrossed)
- HB 1046 authorize the Board of Regents to contract for the design, renovation of, and addition to, the Devereaux Library on the campus of the South Dakota School of Mines and Technology and to make an appropriation therefor. (Joint Appropriations Engrossed)
