Draft 935**AMENDMENT DRAFT 935A FOR THE BILL**

1 **An Act to provide for the postponement of certain elections and to declare an**
2 **emergency.**

3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF SOUTH DAKOTA:

4 **Section 1.** Notwithstanding any other provision of law, any election scheduled to be held
5 from April 14, 2020, through ~~May 26~~June 1, 2020, shall be postponed in the interest of
6 public health and safety. Any candidate deadline associated with the original election date
7 shall remain in place. ~~The members of the governing body of the political subdivision~~
8 holding the election shall choose any Tuesday in June 2020 as The primary election date
9 of June 2, 2020, is the alternate election date.

10 If the governing body of the political subdivision chooses to hold the election on
11 the primary election date of June 2, 2020,For the election the following provisions are
12 required:

13 ~~(1)~~ The combined election is subject to approval by the county commission of any
14 county in which the political subdivision is located;

15 ~~(2)~~(1) Any expense from a combined election shall be apportioned in a manner agreed
16 upon by the governing body of the subdivision and the county commission of each
17 county in which the political subdivision is located; and

18 ~~(3)~~(2) Any other obligation arising under state law for either election shall be handled as
19 agreed upon by the governing body of the subdivision and the county commission
20 of each county in which the political subdivision is located.

21 The person in charge of the election shall use any and all reasonable means
22 necessary to notify any eligible voter in the jurisdiction regarding the postponement of an
23 election under this section. ~~Upon the selection of an election date consistent with this~~
24 section, theThe person in charge of the election shall publish a notice of election once each
25 week for the two consecutive weeks prior to the election. A facsimile of the official ballot

1 shall be published in one of the two calendar weeks prior to ~~each-the~~ election. The notice
2 and ballot shall be published in the official newspaper of the jurisdiction.

3 For any election postponed under this section, any absentee voting period that
4 opened prior to postponement shall extend through 5:00 p.m. local time the day before
5 ~~the new election date~~June 2, 2020.

6 ~~If further postponement is necessary due to public health concerns, the Governor~~
7 ~~may postpone any election, except the general election, to a date no later than July 28,~~
8 ~~2020. The Governor shall provide the alternate dates on which the election may be held.~~

9 **Section 2.** This Act is repealed on ~~December 31~~July 1, 2020.

10 **Section 3.** Whereas, this Act is necessary for the support of the state government and its
11 existing public institutions, an emergency is hereby declared to exist, and this Act shall be in
12 full force and effect from and after its passage and approval.
