14 **Section 9.** Adjust all totals accordingly in sections 1 to 8, inclusive, of this Act.

15 **Section 10.** Funds appropriated by this Act which are unspent at the end of fiscal year 2020
16 may be carried over to fiscal year 2021.

17 **Section 11.** This Act is effective June 29, 2020.
