1 FOR AN ACT ENTITLED, An Act to revise certain requirements of the director of the Office
2 of Laboratory Services.

3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF SOUTH DAKOTA:

4 Section 1. That § 1-49-2 be amended to read as follows:

5 1-49-2. The ~~Governor~~ secretary of the Department of Health shall appoint the director of the
6 Office of Laboratory Services. The ~~director shall hold a doctoral degree in chemistry, biology,~~
7 ~~zoology, the medical sciences or related fields and~~ Office of Laboratory Services shall meet all
8 applicable state and federal certification standards and regulations, and provide, ~~but is not limited~~
9 ~~to,~~ the following specific laboratory, testing and analytical functions:

- 10 (1) The examination of clinical and environmental specimens for the purpose of
11 protecting and promoting the public health;
- 12 (2) The testing and analysis of various products, foods, drinks, economic poisons, and
13 other materials regulated or controlled by the state;
- 14 (3) The testing, examination, and analysis of samples relating to environmental control;
- 15 (4) Laboratory services upon request and in support of law enforcement agencies.
