1 FOR AN ACT ENTITLED, An Act to regulate certain conduct involving fires on public land
2 and to establish related penalties.

3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF SOUTH DAKOTA:

4 Section 1. Except in the Black Hills Forest Fire Protection District where it is a Class 1
5 misdemeanor, it is a Class 2 misdemeanor for any person to start or allow to start an open fire
6 on public lands owned, leased, controlled, or managed by the State or any political subdivision
7 of the State unless the fire is set in an established fireplace approved or provided by the
8 respective governmental entity. This section does not apply to persons authorized by the State
9 or any political subdivision of the State to start fires on such lands within the jurisdiction of the
10 respective governmental entity or to fires on shoreline barren of vegetation which do not
11 constitute an apparent risk of fire to surrounding vegetation not located within a state, county,
12 or municipal park, state recreation area, or nature preserve.

13 Section 2. It is a Class 1 misdemeanor for any person to start or allow to start an open fire
14 and fail to extinguish that fire on public lands owned, leased, controlled, or managed by the State
15 or any political subdivision of the State regardless of whether the fire was started in an approved

1 fireplace.

2 Section 3. Anyone engaging in any of the activities prohibited by section 1 or 2 of this Act
3 or § 34-35-9 is liable for all damages caused by the fire and all fire suppression and
4 extinguishment costs. Criminal prosecution is not a prerequisite to liability for damages or for
5 fire suppression and extinguishment cost.

6 Section 4. That § 41-17-25 be repealed.
