SENATE BILL NO. 236

- 1 FOR AN ACT ENTITLED, An Act to provide for legislative redistricting by a bipartisan,
- 2 nonlegislative commission and to declare an emergency.
- 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF SOUTH DAKOTA:
- 4 Section 1. A commission of seven citizens, none of whom may be public officials, shall be
- 5 selected to prepare the plan for redistricting the state into legislative districts.
- 6 Section 2. The majority and minority leaders of each house shall each designate one
- 7 commissioner. A commissioner shall be appointed from each district listed in section 3 of this
- 8 Act. The majority leader of the Senate has first choice of the district from which the majority
- 9 leader will select a commissioner. The majority leader of the House of Representatives has
- second choice; the minority leader of the Senate has third choice; the minority leader of the
- House of Representatives has fourth choice. Within twenty days after their designation, the four
- commissioners shall select the fifth, sixth, and seventh members. If the four members fail to select
- the fifth, sixth, and seventh member within the time prescribed, chief justice of the Supreme

- 1 Court shall select the fifth, sixth, and seventh member.
- 2 Section 3. The commission districts are the following counties:
- 3 (1) District 1 Minnehaha;
- 4 (2) District 2 Brookings, Clark, Codington, Day, Deuel, Grant, Hamlin, Kingsbury,
- 5 Lake, Marshall, Miner, Moody, and Roberts,
- 6 (3) District 3 Aurora, Bon Homme, Brule, Charles Mix, Clay, Davison, Douglas,
- 7 Gregory, Hanson, Hutchinson, Lincoln, McCook, Turner, Union, and Yankton;
- 8 (4) District 4 Beadle, Brown, Buffalo, Campbell, Edmunds, Faulk, Hand, Hughes,
- 9 Hyde, Jerauld, McPherson, Potter, Sanborn, Spink, Sully, and Walworth;
- 10 (5) District 5 Butte, Corson, Dewey, Haakon, Harding, Lawrence, Meade, Perkins,
- 11 Stanley, and Ziebach;
- 12 (6) District 6 Bennett, Custer, Fall River, Jackson, Jones, Lyman, Mellette, Shannon,
- Todd, and Tripp;
- 14 (7) District 7 Pennington.
- 15 Section 4. If a vacancy occurs on the commission, the appointing authority of the vacated
- seat shall designate a successor.
- 17 Section 5. The members shall select a presiding officer from among themselves.
- Section 6. Commissioners are entitled to the same compensation and expenses as provided
- 19 to members of the Legislature while attending commission meetings or carrying out the official
- 20 duties of the commission.
- 21 Section 7. No member of the commission may run for election to a legislative seat within two
- years after the redistricting plan in which the member participated becomes effective.
- Section 8. The director of the Legislative Research Council, under the direction of the
- 24 Executive Board, shall provide the technical staff and clerical services that the commission needs

- 1 to prepare its districting plan.
- 2 Section 9. Upon request state agencies shall cooperate with the commission and furnish
- 3 technical assistance and consulting personnel.
- 4 Section 10. Before the commission submits its legislative redistricting plan to the Legislature,
- 5 it shall hold at least one public hearing on the plan at the state capitol, one in Sioux Falls, one in
- 6 Rapid City, and two on major Indian reservations. The commission may hold other hearings as
- 7 it deems necessary.
- 8 Section 11. The commission shall submit its legislative redistricting plan to the Legislature
- 9 by September 20, 2001.
- Section 12. Within thirty days after the commission submits its legislative redistricting plan
- 11 to the Legislature, the Legislature shall return the plan to the commission with its
- 12 recommendations.
- Section 13. Within thirty days after receiving the legislative redistricting plan and the
- 14 Legislature's recommendations, the commission shall file its final legislative redistricting plan
- with the secretary of state and it shall become law.
- Section 14. Whereas, this Act is necessary for the support of the state government and its
- existing public institutions, an emergency is hereby declared to exist, and this Act shall be in full
- force and effect from and after its passage and approval.
