6	Section 2. That § 58-30-121 be amended to read as follows:
7	58-30-121. The Division of Insurance shall charge each licensee an additional fee of ten thirty
8	dollars upon renewal of the license. The fee is due on May 1, 2004, and at the beginning of each
9	succeeding twenty-four-month period. The fee shall be deposited in a separate account, entitled
10	the South Dakota insurance producer's continuing education fund, as funding for the
11	administration of the continuing education program. The director may withhold or not renew the
12	license of any licensee who fails to tender timely payment of the fee.
