1 FOR AN ACT ENTITLED, An Act to repeal certain provisions, commonly known as the gag
2 law, prohibiting certain disclosures by a state agency of information concerning a private
3 entity.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF SOUTH DAKOTA:

5 Section 1. That § 1-27-28 be repealed.

6 ~~1-27-28. Terms used in §§ 1-27-29 to 1-27-32, inclusive, mean:~~

7 ~~(1) "Private entity," any person or entity that is not a public entity as defined by~~
8 ~~subdivision 3-21-1(2);~~

9 ~~(2) "State agency," each association, authority, board, commission, committee, council,~~
10 ~~department, division, state office, task force, and their officers, legal representatives,~~
11 ~~consultants, or other agents. The term does not include the Legislature, the Unified~~
12 ~~Judicial System, any law enforcement agency, or any unit of local government.~~

13 Section 2. That § 1-27-29 be repealed.



1 ~~1-27-29. A state agency which is authorized by law to investigate, examine, or audit the~~
2 ~~papers, books, records, financial condition, or other information held by or concerning a private~~
3 ~~entity may not disclose that it is conducting such an investigation, examination, or audit, except~~
4 ~~as provided by §§ 1-27-28 to 1-27-32, inclusive.~~

5 Section 3. That § 1-27-30 be repealed.

6 ~~1-27-30. All information obtained from or concerning the private entity by the state agency~~
7 ~~as a result of such an investigation, examination, or audit is confidential, except as provided by~~
8 ~~§§ 1-27-28 to 1-27-32, inclusive.~~

9 Section 4. That § 1-27-31 be repealed.

10 ~~1-27-31. A state agency may not disclose that it is investigating, examining, or auditing a~~
11 ~~private entity, and may only disclose the information obtained from such an investigation,~~
12 ~~examination, or audit as follows:~~

13 ~~(1) To the private entity being investigated, examined, or audited;~~

14 ~~(2) To those persons whom the private entity has authorized in writing to receive such~~
15 ~~information;~~

16 ~~(3) To the officers, employees, or legal representatives of any other state agency which~~
17 ~~requests the information in writing for the purpose of investigating and enforcing civil~~
18 ~~or criminal matters. The written request will specify the particular information desired~~
19 ~~and the purpose for which the information is requested;~~

20 ~~(4) To any administrative or judicial body if the information is directly related to the~~
21 ~~resolution of an issue in the proceeding, or pursuant to an administrative or judicial~~
22 ~~order. However, no person may use a subpoena, discovery, or other applicable~~
23 ~~statutes to obtain such information;~~

24 ~~(5) To another state pursuant to an agreement between the State of South Dakota and~~

1 ~~the other state, but only if the other state agrees to keep the information confidential~~
2 ~~as set forth in §§ 1-27-28 to 1-27-32, inclusive;~~

3 ~~(6) To the attorney general, state's attorney, or any state, federal, or local law~~
4 ~~enforcement officer;~~

5 ~~(7) To a federal agency pursuant to the provisions of federal law;~~

6 ~~(8) To the extent necessary to submit any final reports or filings which are otherwise~~
7 ~~required by law to be prepared or filed;~~

8 ~~(9) For investigations to protect the natural resources of the state; or~~

9 ~~(10) To comply with federal law, rules, or program delegation requirements.~~

10 Section 5. That § 1-27-32 be repealed.

11 ~~1-27-32. Disclosure of information made confidential by §§ 1-27-28 to 1-27-32, inclusive,~~
12 ~~except as provided in § 1-27-31, is a Class 6 felony.~~
