

## 2022 South Dakota Legislature

**House Bill 1206****AMENDMENT 1206A FOR THE INTRODUCED BILL**

1 **An Act to establish fees for information provided from the statewide voter**  
2 **registration file.**

3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF SOUTH DAKOTA:

4 **Section 1. That chapter 12-4 be amended with a NEW SECTION:**

5 The fees for obtaining a copy of an electronic file with voter registration information  
6 are as follows:

7 (1) Statewide complete file, ~~one thousand two hundred fifty two thousand five hundred~~  
8 dollars;

9 (2) Statewide complete file for new parties or parties with alternative political status  
10 for just their party voters:

11 (a) ~~Ten~~Fifteen dollars for one thousand names or less;

12 (b) ~~Twenty-five~~Fifty dollars for one thousand one to ten thousand names,  
13 inclusive;

14 (c) ~~Fifty~~One hundred dollars for ten thousand one to twenty-five thousand  
15 names, inclusive; and

16 (d) ~~One hundred twenty-five~~Two hundred fifty dollars for more than twenty-  
17 five thousand names;

18 (3) Legislative district complete file, ~~fifty one hundred~~ dollars;

19 (4) County or any other district complete file:

20 (a) ~~Ten~~Fifteen dollars for one thousand names or less;

21 (b) ~~Twenty-five~~Fifty dollars for one thousand one to ten thousand names,  
22 inclusive;

23 (c) ~~Fifty~~One hundred dollars for ten thousand one to twenty-five thousand  
24 names, inclusive; and

25 (d) ~~One hundred twenty-five~~Two hundred fifty dollars for more than twenty-  
26 five thousand names;

- 1        (5) Any updated partial file that contains only changes made within a year after the  
 2        purchase of a complete file;  
 3        (a) ~~One hundred twenty five~~ ~~Two hundred fifty~~ dollars for a statewide partial  
 4        file; and  
 5        (b) ~~Fifteen~~ ~~Twenty-five~~ dollars for a legislative district, any other district, or  
 6        county partial file.

7        **Section 2. That chapter 12-4 be amended with a NEW SECTION:**

- 8        The fees for obtaining a paper list with voter registration information are as follows:  
 9        (1) Statewide complete list, five thousand five hundred dollars;  
 10       (2) Statewide complete list for new parties or parties with alternative political status  
 11       for just their party voters:  
 12       (a) Twenty dollars for one thousand names or less;  
 13       (b) Seventy-five dollars for one thousand one to ten thousand names, inclusive;  
 14       (c) Two hundred dollars for ten thousand one to twenty-five thousand names,  
 15       inclusive; and  
 16       (d) Six hundred dollars for more than twenty-five thousand names;  
 17       (3) Legislative district complete list, two hundred dollars;  
 18       (4) County or any other district complete list:  
 19       (a) Twenty dollars for one thousand names or less;  
 20       (b) Seventy-five dollars for one thousand one to ten thousand names, inclusive;  
 21       (c) Two hundred dollars for ten thousand one to twenty-five thousand names,  
 22       inclusive; and  
 23       (d) Six hundred dollars for more than twenty-five thousand names;  
 24       (5) Any updated partial list that contains only changes made within a year after the  
 25       purchase of a complete list:  
 26       (a) Five hundred fifty dollars for a statewide partial list; and  
 27       (b) Sixty dollars for a legislative district, any other district, or county partial  
 28       list.

29       **Section 3. That chapter 12-4 be amended with a NEW SECTION:**

- 30       The fees for obtaining a copy of an electronic file with daily absentee voter  
 31       registration information per election are as follows:  
 32       (1) Statewide complete file, ~~one thousand five hundred~~ ~~three thousand~~ dollars;  
 33       (2) Legislative district complete file, ~~seventy-five~~ ~~one hundred fifty~~ dollars; and

- 1       (3) County complete file:
- 2           (a) ~~Thirty five~~Sixty-five dollars for one thousand names or less;
- 3           (b) ~~Fifty One hundred~~ dollars for one thousand one to ten thousand names,
- 4                 inclusive;
- 5           (c) ~~Seventy five~~One hundred fifty dollars for ten thousand one to twenty-five
- 6                 thousand names, inclusive; and
- 7           (d) ~~One hundred fifty~~Three hundred dollars for more than twenty-five thousand
- 8                 names.

9       **Section 4. That § 12-4-39 be AMENDED:**

- 10               **12-4-39.** The secretary of state may promulgate rules pursuant to chapter 1-26
- 11       concerning:
- 12           (1) Procedures for the establishing the statewide voter registration file;
- 13           (2) Transmission of the voter registration information from the county to the Office of
- 14                 the Secretary of State;
- 15           (3) Procedures for determining duplicate voter registration; and
- 16           (4) Dissemination of the information from the statewide voter registration file; and
- 17       ~~(5) Establishment of fees for information provided from the statewide voter registration~~
- 18                 file.
