| 4        | Section 1. There is hereby transferred from the general fund to the South Dakota Housing   |
| 5        | Opportunity fund, created in § 11-13-2, the sum of \$150,000,000. The South Dakota Housing   |
| 6        | Development Authority shall administer the moneys so transferred for the purpose of  |
| 7        | providing:   |
| 8<br>9   | (1) Loans in the sum of \$100,000,000 for the construction of housing infrastructure;  and   |
| 10       | (2) Grants in the sum of \$50,000,000 for the construction of housing infrastructure.  |
| 11<br>12 | <b>Section 2.</b> Federal fund expenditure authority is hereby appropriated in the sum of \$50,000,000 from the American Rescue Plan Act to the South Dakota Housing Development |
| 13       | Authority, for the purpose of providing grants for the construction of housing infrastructure.   |
| 14       | Section 3. Loans or grants made available pursuant to this Act must be designated as follows:  |
| 15       | (1) Thirty percent for use in municipalities having a population of fifty thousand or  |
| 16       | more; and  |
| 17       | (2) Seventy percent for use in all other areas of the state.   |
| 18       | Any housing infrastructure project sited in a municipality having a population of  |
| 19       | fifty thousand or more may receive either a loan or a grant from moneys appropriated or  |
| 20       | authorized under this Act, but may not receive both.   |

- 1 Section 4. Any grant made available by the South Dakota Housing Development Authority
- 2 pursuant to this Act may not be for an amount greater than one-third of the project's total
- 3 cost.
- 4 **Section 5.** For purposes of this Act, the term, housing infrastructure, means public:
- 5 (1) Rights of way;
- 6 (2) Water distribution systems;
- 7 (3) Sanitary and storm sewers;
- 8 (4) Streets, roads, and bridges;
- 9 (5) Curbs, gutters, and sidewalks;
- 10 (6) Lift stations;
- 11 (7) Excavation and compaction;
- 12 <u>(8) Traffic signals;</u>
- 13 (9) Street lighting;
- 14 (10) The purchase of land necessary to accommodate projects listed in this section; and
- 15 (11) Any other infrastructure project determined by the South Dakota Housing
- Development Authority to be consistent with the purposes of this Act.
- 17 **Section 6. The** executive director of the South Dakota Housing Development Authority shall
- 18 approve vouchers and the state auditor shall draw warrants to pay expenditures authorized
- 19 by this Act.
- 20 Section 7. This Act is effective on June 27, 2022.
