Senate Bill 121**AMENDMENT 121C
FOR THE INTRODUCED BILL**

1 **An Act to reduce maximum values for certain property taxes levied on owner-**
2 **occupied single-family dwellings, and to increase the rates for certain gross**
3 **receipts taxes and use taxes.**

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF SOUTH DAKOTA:

5 **Section 1.** It is the intention of the Legislature that the proceeds of the tax rate increases in
6 sections 3 to 18, inclusive, and section ~~24~~ 22 of this Act, be used to supplant all unrealized
7 property tax revenue resulting from ~~a the reduction of the mill levy of zero being~~ applied to
8 owner-occupied single-family dwellings under section 2 of this Act, for school district general
9 funds ~~and school district special education funds~~.

10 It is the intention of the Legislature that ~~these levies the reduction of the mill levy under~~
11 section 2 of this Act for owner-occupied single-family dwellings ~~do does~~ not affect the mill
12 levies for the other classifications of real property, and ~~do does~~ not adversely affect the total
13 amount of moneys available to school districts through the school district funding ~~formulas~~
14 formula for general funds ~~and special education funds~~.

15 **Section 2. That § 10-12-42 be AMENDED:**

16 **10-12-42.** For taxes payable in ~~2025~~ 2026, and each year thereafter, the levy for
17 the general fund of a school district is as follows:

- 18 (1) The maximum ~~tax~~ mill levy is five dollars and fifty-four and four-tenths cents per
19 thousand dollars of taxable valuation, subject to the limitations on agricultural
20 property as provided in subdivision (2) ~~of this section~~ and owner-occupied property
21 as provided in subdivision (3) ~~of this section~~;
- 22 (2) The maximum ~~tax~~ mill levy on agricultural property for the school district is one
23 dollar and nineteen and seven-tenths cents per thousand dollars of taxable
24 valuation. If the district's levies are less than the maximum levies as stated in this
25 section, the mill levies imposed in subdivisions (1) and (2) must maintain the same

1 proportion to each other as represented in the mathematical relationship at the
2 maximum mill levies; and

3 (3) The maximum ~~tax~~ mill levy for an owner-occupied single-family dwelling pursuant
4 to § 10-13-40 for the school district is ~~two dollars and sixty-seven and nine tenths~~
5 ~~cents~~ zero dollars one dollar and zero cents per thousand dollars of taxable
6 valuation. ~~If the district's levies are less than the maximum levies as stated in this~~
7 ~~section, the levies must maintain the same proportion to each other as represented~~
8 ~~in the mathematical relationship at the maximum levies.~~

9 All levies in this section must be imposed on valuations where the median level of
10 assessment represents eighty-five percent of market value as determined by the
11 Department of Revenue. These valuations must be used for all school funding purposes.
12 If the district has imposed an excess levy pursuant to § 10-12-43, the levies must
13 maintain the same proportion to each other as represented in the mathematical
14 relationship at the maximum levies in this section for taxes payable in 2025. The school
15 district may elect to tax at less than the maximum amounts set forth in this section.

16 **Section 3. That § 10-45-2 be AMENDED:**

17 **10-45-2.** There is hereby imposed a tax upon the privilege of engaging in business
18 as a retailer, a tax ~~of four and two tenths~~ at the rate of five four and one-half percent
19 upon the gross receipts of all sales of tangible personal property consisting of goods,
20 wares, or merchandise, except as otherwise provided in this chapter, sold at retail in the
21 state to consumers or users.

22 **Section 4. That § 10-45-5 be AMENDED:**

23 **10-45-5.** There is imposed a tax, at the same ~~rate of four and two tenths percent~~
24 ~~set forth in § 10-45-2,~~ upon the gross receipts of any person from engaging or continuing
25 in any of the following businesses or services in this state:

- 26 (1) ~~abstracters~~ Abstracters;
- 27 (2) ~~accountants~~ Accountants;
- 28 (3) ~~ancillary~~ Ancillary services;
- 29 (4) ~~architects~~ Architects;
- 30 (5) ~~barbers~~ Barbers;
- 31 (6) ~~beauty~~ Beauty shops;
- 32 (7) ~~bill~~ Bill collection services;
- 33 (8) ~~blacksmith~~ Blacksmith shops;

- 1 (9) carCar washing;
- 2 (10) dryDry cleaning;
- 3 (11) dyeingDyeing;
- 4 (12) exterminatorsExterminators;
- 5 (13) garageGarage and service stations;
- 6 (14) garmentGarment alteration;
- 7 (15) cleaningCleaning and pressing;
- 8 (16) janitorialJanitorial services and supplies;
- 9 (17) specialtySpecialty cleaners;
- 10 (18) laundryLaundry;
- 11 (19) linenLinen and towel supply;
- 12 (20) membershipMembership or entrance fees for the use of a facility or for the right to
- 13 purchase tangible personal property, any product transferred electronically, or
- 14 services;
- 15 (21) photographyPhotography;
- 16 (22) photoPhoto developing and enlarging;
- 17 (23) tireTire recapping;
- 18 (24) weldingWelding and all repair services, except repair services for farm machinery,
- 19 attachment units, and irrigation equipment used exclusively for agricultural
- 20 purposes;
- 21 (25) cableCable television; and
- 22 (26) rentalsRentals of tangible personal property except leases of tangible personal
- 23 property between one telephone company and another telephone company, motor
- 24 vehicles as defined pursuant to § 32-5-1 leased under a single contract for more
- 25 than twenty-eight days, and mobile homes.
- 26 However, ~~the~~The specific enumeration of businesses and professions made in this
- 27 section does not, in any way, limit the scope and effect of the provisions of § 10-45-4.

28 **Section 5. That § 10-45-5.3 be AMENDED:**

29 **10-45-5.3.** There is imposed, at the same rate of four and two-tenths percent set

30 forth in § 10-45-2, an excise tax on the gross receipts of any person engaging in oil and

31 gas field services (group no. 138) as enumerated in the Standard Industrial Classification

32 Manual, 1987, as prepared by the Statistical Policy Division of the Office of Management

33 and Budget, Office of the President.

1 **Section 6. That § 10-45-6 be AMENDED:**

2 **10-45-6.** There is hereby imposed a tax ~~of four and two tenths percent, at the~~
3 same rate set forth in § 10-45-2, upon the gross receipts from sales, furnishing, or service
4 of gas, electricity, and water, including the gross receipts from ~~such~~ these sales by any
5 municipal corporation furnishing gas, and electricity, to the public in its proprietary
6 capacity, except as otherwise provided in this chapter, when sold at retail in ~~the State of~~
7 South Dakota this state to consumers or users.

8 **Section 7. That § 10-45-6.1 be AMENDED:**

9 **10-45-6.1.** Except as provided in § 10-45-6.2, there is hereby imposed a tax ~~of~~
10 four and two tenths percent, at the same rate set forth in § 10-45-2, upon the gross
11 receipts from providing any intrastate, interstate, or international telecommunications
12 service that originates or terminates in this state and that is billed or charged to a service
13 address in this state, or that both originates and terminates in this state. However, the
14 tax imposed by this section does not apply to:

- 15 (1) Any eight hundred or eight hundred-type service, unless the service both originates
16 and terminates in this state;
- 17 (2) Any sale of a telecommunication service to a provider of telecommunication
18 services, including access service, for use in providing any telecommunication
19 service; or
- 20 (3) Any sale of interstate telecommunication service provided to a call center that has
21 been certified by the secretary of revenue to meet the criterion established in § 10-
22 45-6.3 and the call center has provided to the telecommunications service provider
23 an exemption certificate issued by the secretary indicating that it meets the
24 criterion.

25 If a call center uses an exemption certificate to purchase services not meeting the
26 criterion established in § 10-45-6.3, the call center is liable for the applicable tax, penalty,
27 and interest.

28 **Section 8. That § 10-45-6.2 be AMENDED:**

29 **10-45-6.2.** There is hereby imposed a tax ~~of four and two tenths percent, at the~~
30 same rate set forth in § 10-45-2, upon the gross receipts of mobile telecommunications
31 services, as defined in 4 U.S.C. § 124(7) ~~as of~~ (January 1, 2002), that originate and
32 terminate in the same state and are billed to a customer with a place of primary use in

1 this state or are deemed to have originated or been received in this state and to be billed
2 or charged to a service address in this state if the customer's place of primary use is
3 located in this state regardless of where the service actually originates or terminates.
4 Notwithstanding any other provision of this chapter and for purposes of the tax imposed
5 by this section, the tax imposed upon mobile telecommunication services must be
6 administered in accordance with 4 U.S.C. §§ 116-126, ~~as in effect on~~ (July 28, 2000).

7 **Section 9. That § 10-45-8 be AMENDED:**

8 **10-45-8.** Except as otherwise provided in this chapter, there is imposed a tax ~~of~~
9 ~~four and two tenths percent,~~ at the same rate set forth in § 10-45-2, upon the gross
10 receipts from all sales of tickets or admissions to:

- 11 (1) Places of amusement;
12 (2) Athletic contests; or
13 (3) Events.

14 **Section 10. That § 10-45-71 be AMENDED:**

15 **10-45-71.** There is imposed a tax ~~of four and two tenths percent,~~ at the same
16 rate set forth in § 10-45-2, on the gross receipts from the transportation of passengers.
17 The tax imposed by this section applies to any transportation of passengers if the
18 passenger boards and exits the mode of transportation within this state.

19 **Section 11. That § 10-46-2.1 be AMENDED:**

20 **10-46-2.1.** For the privilege of using services in ~~South Dakota~~ this state, except
21 those types of services exempted by § 10-46-17.3, there is imposed on the person using
22 the service an excise tax ~~equal to four and two tenths~~ at a rate of ~~five~~ four and one-half
23 percent of the value of the services at the time they are rendered. ~~However, this~~ This tax
24 may not be imposed on any service rendered by a related corporation, as defined in
25 subdivision 10-43-1(11), for use by a financial institution, as defined in subdivision 10-
26 43-1(4); ~~or on any service rendered by a financial institution,~~ as defined in subdivision
27 10-43-1(4), for use by a related corporation as defined in subdivision 10-43-1(11) and as
28 provided below.

29 For the purposes of this section, the term, related corporation, includes a
30 corporation, which together with the financial institution, is part of a controlled group of
31 corporations, as defined in 26 U.S.C. § 1563 ~~as in effect on~~ (January 1, 1989), except that

1 the eighty percent ownership requirements set forth in 26 U.S.C. ~~§ 563(a)(2)(A)~~ §
2 1563(a) for a brother-sister controlled group are reduced to fifty-one percent.

3 For the purpose of this chapter, services rendered by an employee for the use of
4 the employer are not taxable.

5 **Section 12. That § 10-46-2.2 be AMENDED:**

6 **10-46-2.2.** An excise tax is imposed upon the privilege of the use of rented
7 tangible personal property and any product transferred electronically in this state at the
8 ~~same rate of four and two tenths percent set forth in § 10-46-2.1, or on~~ the rental
9 payments upon the property.

10 **Section 13. That § 10-46-58 be AMENDED:**

11 **10-46-58.** There is imposed a tax ~~of four and two tenths percent, at the same~~
12 ~~rate set forth in § 10-46-2.1, or upon~~ the privilege of the use of any transportation of
13 passengers. The tax imposed by this section applies to any transportation of passengers
14 if the passenger boards and exits the mode of transportation within this state.

15 **Section 14. That § 10-46-69 be AMENDED:**

16 **10-46-69.** There is hereby imposed a tax ~~of four and two tenths percent, at the~~
17 ~~same rate set forth in § 10-46-2.1,~~ upon the privilege of the use of mobile
18 telecommunications services, as defined in 4 U.S.C. § 124(7) ~~as of (January 1, 2002),~~
19 that originate and terminate in the same state and are billed to a customer with a place
20 of primary use in this state. Notwithstanding any other provision of this chapter and for
21 purposes of the tax imposed by this section, the tax imposed upon mobile
22 telecommunication services must be administered in accordance with 4 U.S.C. §§ 116-
23 126, ~~as in effect on (July 28, 2000).~~

24 **Section 15. That § 10-46-69.1 be AMENDED:**

25 **10-46-69.1.** Except as provided in § 10-46-69, there is hereby imposed a tax ~~of~~
26 ~~four and two tenths percent, at the same rate set forth in § 10-46-2.1,~~ upon the privilege
27 of the use of any intrastate, interstate, or international telecommunications service that
28 originates or terminates in this state and that is billed or charged to a service address in
29 this state, or that both originates and terminates in this state. ~~However, the~~ The tax
30 imposed by this section does not apply to:

- 1 (1) Any eight hundred or eight hundred type service, unless the service both originates
2 and terminates in this state;
- 3 (2) Any sale of a telecommunication service to a provider of telecommunication
4 services, including access service, for use in providing any telecommunication
5 service; or
- 6 (3) Any sale of interstate telecommunication service provided to a call center that has

14 **Section 16. That § 10-46-69.2 be AMENDED:**

15 **10-46-69.2.** There is hereby imposed a tax of ~~four and two tenths percent~~, at the
16 same rate set forth in § 10-46-2.1, upon the privilege of the use of any ancillary services.

17 **Section 17. That § 10-46E-1 be AMENDED:**

18 **10-46E-1.** There is hereby imposed an excise tax of ~~four and two tenths~~ five four
19 and one-half percent on the gross receipts from the sale, resale, or lease of farm
20 machinery, attachment units, and irrigation equipment used exclusively for agricultural
21 purposes. ~~However, if~~ If any trade-in or exchange of used farm machinery, attachment
22 units, and irrigation equipment is involved in the transaction, the excise tax is only due
23 and may only be collected on the cash difference.

24 **Section 18. That § 10-58-1 be AMENDED:**

25 **10-58-1.** There is imposed upon owners and operators a special amusement
26 excise tax of ~~four and two tenths~~ five four and one-half percent of the gross receipts from
27 the sale or the operation of any mechanical or electronic amusement device. The tax
28 imposed by this section is in lieu of the tax imposed pursuant to chapter 10-45.

29 **~~Section 19. That § 13-37-16 be AMENDED:~~**

1 ~~13-37-16.~~ For taxes payable in ~~2025-2026,~~ and each year thereafter, the school board shall
 2 levy no more than one dollar and forty-eight and eight-tenths cents per thousand dollars of
 3 taxable valuation of property classified for purposes of taxation as agricultural property or
 4 nonagricultural property, as a special levy in addition to all other levies authorized by law for
 5 the amount so determined to be necessary, and the levy must be spread against all of the
 6 taxable property of the district not classified as owner-occupied single-family dwellings, as
 7 defined in § 10-13-39. The proceeds derived from the levy constitute a school district special
 8 education fund of the district for the payment of costs for the special education of all children
 9 in need of special education or special education and related services, who reside within the
 10 district, pursuant to the provisions of §§ ~~13-37-8.4 to 13-37-8.10,~~ inclusive.

11 The levy in this section is based on valuations where the median level of assessment
 12 represents eighty-five percent of market value, as determined by the Department of Revenue.
 13 The total amount of taxes that would be generated at the levy pursuant to this section is
 14 considered local effort. Money in the special education fund may be expended for the purchase
 15 or lease of any assistive technology that is directly related to special education and specified
 16 in a student's individualized education plan. This section does not apply to real property
 17 improvements.

18 **Section 20. That § 13-37-35.1 be AMENDED:**

19 ~~13-37-35.1.~~ Terms used in chapter 13-37 mean:

4 ~~(14) "Fall enrollment," the number of kindergarten through twelfth-grade~~
5 ~~students enrolled in all schools operated by the school district on the last Friday of September~~
6 ~~of the previous school year minus the number of students for whom the district receives~~
7 ~~tuition, except any nonresident student who is in the care and custody of a state agency and~~
8 ~~is attending a public school and any student for whom tuition is being paid pursuant to § 13-~~

16 ~~South Dakota School for the Blind and Visually Impaired;~~

17 ~~(i) Sum the results of subdivisions (18)(a) to (h), inclusive;~~

18 ~~(19) ——— "Effort factor," the school district's special education tax levy in dollars~~
19 ~~per thousand divided by \$1.288. The maximum effort factor is 1.0.~~

20 **Section 19. That § 13-13-71 be AMENDED:**

21 **13-13-71.** If local effort increases on a statewide aggregate basis by a greater
22 percentage than local need on a statewide aggregate basis from any one year to the next,
23 for the following year each of the mill levies specified in ~~subdivision 13-13-10.1(13)~~ shall
24 subdivisions 10-12-42(1) and (2) must be reduced proportionally so that the percentage
25 increase in local effort on a statewide aggregate basis equals the percentage increase in
26 need on a statewide aggregate basis.

27 **Section 20. That § 13-13-72 be AMENDED:**

1 **13-13-72.** ~~It is the policy of the Legislature that~~ In 2026 and each year thereafter,
 2 the appropriation for state aid to education must ~~increase on an annual basis~~ annually by
 3 the percentage increase in local need on an aggregate statewide basis so that the relative
 4 proportion of local need paid by local effort and state aid ~~shall~~ remain constant. ~~For school~~
 5 fiscal years 2017 to 2022, inclusive, ~~the proportion of local need paid by local effort and~~
 6 state aid ~~shall be adjusted annually to maintain the proportion between state aid and local~~
 7 property taxes and to reflect adjustments in local effort due to the implementation of the
 8 other revenue base amount as defined in § 13-13-10.1.

22 **32-5B-20.** There is hereby imposed a tax of ~~four and two tenths~~ five four and
 23 one-half percent upon the gross receipts of any person renting a rental vehicle as defined

 26 or 32-5-9 is subject to the motor vehicle excise tax in § 32-5B-1.

27 The tax imposed by this section is in addition to any tax levied pursuant to chapter
 28 10-45 or 10-46 upon the rental of a rental vehicle. The provisions of chapter 10-45 apply
 29 to the administration and enforcement of the tax imposed by this section. The tax imposed
 30 by this section is in lieu of the tax levied by § 32-5B-1 on the sales of such motor vehicles.
