

## 2020 South Dakota Legislature

**Draft 930****AMENDMENT 1296G FOR THE INTRODUCED BILL**

1 **An Act to revise the authority of the Governor in times of a disaster, act of terrorism,**  
2 **or emergency and to declare an emergency.**

3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF SOUTH DAKOTA:

4 **Section 1.** That § 34-48A-5 be AMENDED:

5 **34-48A-5. Authority of Governor in time of disaster, terrorist attack, or**  
6 **emergency--Limitations.**

7 In the event of disaster, war, act of terrorism as defined in state law, or emergency  
8 that is beyond local government capability, the Governor:

- 9 (1) May assume direct operational control over all or any part of the emergency  
10 management functions within the state which may affect all or any portion of the  
11 state;
- 12 (2) May declare an emergency or disaster to exist in the stricken area and employ  
13 emergency management to assist local authorities to affect relief, evacuation, and  
14 restoration as deemed necessary to preserve life or other disaster or emergency  
15 mitigation, response, or recovery;
- 16 (3) May call upon and use any facilities, equipment, other nonmedical supplies, and  
17 resources available from any source, other than personal or private funds, in order  
18 to carry out the purposes of this chapter by contributing to the expense incurred in  
19 providing relief in such amounts as the Governor shall determine. ~~However,~~  
20 provided that nothing in this ~~subdivision-section~~ may be construed to authorize the  
21 taking of firearms, as defined in ~~subdivision 22-1-2(16)~~ § 22-1-2, without the  
22 consent of the owner;
- 23 (4) May suspend ~~the provisions of any regulatory statute of this state prescribing the~~  
24 ~~conduct of state business or the business of a local subdivision, or the orders or~~  
25 ~~rules of any state agency~~ any rule of a state agency, or the enforcement by a state  
26 agency of any statute that regulates, or that prescribes the promulgation of a rule

- 1 to regulate, the procedures for the conduct of state business, if strict compliance  
2 with the provisions of the ~~statute, order, or rule~~ or statute would in any way prevent,  
3 hinder, or delay necessary action in managing a disaster, war, act of terrorism, or  
4 emergency, including fire, flood, earthquake, severe high and low temperatures,  
5 tornado storm, wave action, oil spill, or other water or air contamination, epidemic,  
6 blight, drought, pandemic, infestation, explosion, riot, or hostile military or  
7 paramilitary action, which is determined by the Governor to require state or state  
8 and federal assistance or actions to supplement the recovery efforts of local  
9 governments in alleviating the damage, loss, hardship, or suffering caused thereby;
- 10 (5) May control the ingress and egress in a designated disaster or emergency area, the  
11 movement of vehicles upon highways within the area, the movement of persons  
12 within the area, and the occupancy of premises within the area;
- 13 (6) May procure, acquire, store, distribute, and dispense any pharmaceutical agents or  
14 medical supplies located within the state as may be reasonable and necessary to  
15 respond to the disaster, emergency, or act of terrorism;
- 16 (7) May appoint and prescribe the duties of such out-of-state health care providers as  
17 may be reasonable and necessary to respond to the disaster, emergency, or act of  
18 terrorism;
- 19 (8) May provide for the examination and safe disposal of any dead body as may be  
20 reasonable and necessary to respond to the disaster, emergency, or act of  
21 terrorism; and
- 22 (9) May provide for the protection, construction or reconstruction, repair, and  
23 maintenance of public or private transportation facilities.

24 Nothing in this section may be construed to authorize the suspension of § 34-48A-5.1  
25 or to authorize any activity prohibited under § 34-48A-5.1.

26 The powers granted to the Governor under this section shall remain in effect for a  
27 period of six months and may be restored for one or more successive six-month periods  
28 by declaration of the Governor that the conditions permitting such powers persist.

29 **Section 2.** That a NEW SECTION be added:

30 **34-48A-5.1. Governmental authority--Disaster--Terrorist attack--**  
31 **Emergencies--Limitations related to firearms and weapons.**

32 No state agency, political subdivision, or any elected or appointed official or  
33 employee of this state or of a political subdivision may, under any governmental authority

1 or color of law, including any other statutorily authorized responses to disaster, war, acts  
2 of terrorism, or emergencies of whatever kind or nature:

3 (1) Prohibit, regulate, or curtail the otherwise lawful possession, carrying, sale,  
4 transportation, transfer, defensive use, or other lawful use of any:

5 (a) Firearm, including any component or accessory;

6 (b) Ammunition, including any component or accessory;

7 (c) Ammunition-reloading equipment and supplies; or

8 (d) Personal weapons other than firearms;

9 (2) Seize, commandeer, or confiscate in any manner, any:

10 (a) Firearm, including any component or accessory;

11 (b) Ammunition, including any component or accessory;

12 (c) Ammunition-reloading equipment and supplies; or

13 (d) Personal weapons other than firearms;

14 (3) Suspend or revoke a permit to carry a concealed pistol issued pursuant to chapter  
15 23-7, except as expressly authorized in that chapter;

16 (4) Refuse to accept an application for a permit to carry a concealed pistol, provided  
17 the application has been properly completed in accordance with chapter 23-7;

18 (5) Close or limit the operating hours of any entity engaged in the lawful selling or  
19 servicing of any firearm, including any component or accessory, ammunition,  
20 including any component or accessory, ammunition-reloading equipment and  
21 supplies, or personal weapons other than firearms, unless the closing or limitation  
22 of hours applies equally to all forms of commerce within the jurisdiction;

23 (6) Close or limit the operating hours of any indoor or outdoor shooting range; or

24 (7) Place restrictions or quantity limitations on any entity regarding the lawful sale or  
25 servicing of any:

26 (a) Firearm, including any component or accessory;

27 (b) Ammunition, including any component or accessory;

28 (c) Ammunition-reloading equipment and supplies; or

29 (d) Personal weapons other than firearms.

30 Any person aggrieved by a violation of this section may file an action for damages,  
31 injunctive relief, or other appropriate redress in the circuit court having jurisdiction over  
32 the county in which the aggrieved person resides or in which the violation occurred.

33 **Section 3.** This Act is repealed on July 1, 2021.

- 1 **Section 4.** Whereas, this Act is necessary for the immediate preservation of the public peace,  
2 health, or safety, an emergency is hereby declared to exist, and this Act shall be in full force  
3 and effect from and after its passage and approval.
