



#### UNRESTRICTED ENDOWMENTS

The Foundation will accept restricted endowed gifts, but a primary purpose of the Foundation will be to grow a permanent and unrestricted endowment that will ensure future generations a flexible resource that can address unforeseen challenges and opportunities related to agriculture and rural communities.

# SD Ag Foundation Grant Program Ag Ed Innovation & Leadership Grants

Supporting bringing Innovative Solutions to Agricultural Education

Today's changing Ag Education needs and complex challenges require new thinking and new approaches. That's why we've partnered with the SD Department of Agriculture, and their BOSDRC Grant Program, to offer a funding source for organizations leading the way in providing agriculture education, innovation and leadership programs. With \$35,000 to awarded in grant sizes ranging from \$500 to \$10,000 in 2016, the time to apply for an Ag Ed Innovation & Leadership Grant is now. Here's what you need to know.

## What counts as "Ag Ed Innovation & Leadership"?

We know that there are many possible creative solutions to offering more agriculture related innovation and leadership programs for our Youth. Ag Ed Innovation & Leadership Grants focus on finding these new solutions that are inclusive, collaborative, and resourceful. Ag Ed Innovation & Leadership should address an educational need or opportunity in a more innovative, effective, equitable, or sustainable way than existing approaches.

We are not prioritizing any specific issues and projects can be at various stages of the problem-solving process. We do ask that they are focused on some combination of agriculture, innovation, technology and leadership in the area of youth education.

### **Basic Eligibility**

- Applicants should be a public, nonprofit organization as defined by IRS
   Publication 78. You can also work with a verified fiscal sponsor who
   can receive funds on your behalf.
- The SDAF does not make grants in support of political campaigns, discriminatory practices, or for personal gain.
- Grants must be used for projects located in South Dakota.
- We will favor/prioritize proposals with project budget sizes that are of appropriate scale to this \$500 \$10,000 grant opportunity and appropriate scale to the applicants capacity to execute the project.

# <u>Strategic Planning Meeting – Deliverables, Identified Key Strategic Intervention</u> Points and Action Items

Through the intentional and focused Strategic Planning & Prioritization process that was undertaken, the following results were achieved either during, or soon after, the meetings:

- Agreement on the 4 high priority areas that the foundation has chosen; **Human Capital Development, Industry Diversification and Development, Conservation and Promotion and Service to the Industry**
- Alignment within the group on how we define these areas and have listed below where the identified key strategic intervention points lie within these areas:

#### Rural Life Viability and Support Systems

Projects and Activities focused on the infrastructure and resources needed to maintain a healthy and sustainable support system in rural SD for our agricultural industry.

- And then finally, below are the immediate action items we will be taking on based off of our meetings:

#### **BOSDRC Grants SDDA/SDAF Partnership**

As a result of the strategic planning that occurred during the sessions held in Mitchell, SD in August, 2016, the Foundation recognized an urgent need for the foundation to identify a couple of strategic opportunities to begin to support and implement projects in line with the vision, mission and strategic priorities of the foundation. In line with this thought, the Foundation also

identified two possible paths for implementing this early work – One, to partner with existing exempt organizations and governmental agencies to provide resources that will enhance and expand existing programs; and Two, to develop its own programs and activities that will expand and support current work, or fill in gaps where work is not currently being done, to promote the long term viability of agriculture and rural life in South Dakota. Inherently, the first of these two approaches listed will be the quickest and easiest way for us to kickoff our programatic work as a foundation. That is why we are proposing the following programmatic partnership for the foundation.

The proposed initial plan for your approval is to engage in administering and supporting existing activities that the South Dakota Department of Agriculture has in place, while using the independence of the Foundation to explore opportunities and avenues that have the ability to enhance and expand their work and take them to a higher level of implementation.

The first of these activities is "Building Our South Dakota Rural Communities (BOSDRC)." Currently the South Dakota Department of Agriculture has a grant program for Local 4H Clubs and FFA/FHA Chapters. The purpose of the program is to get youth involved in local community improvement projects. The goal of our partnership will be to engage our private sector board members in the leadership and deployment of the current program, to identify and provide expanded opportunities to support these great local organizations throughout the state through a focus on innovation and leadership programs for our youth in agriculture and then finally to analyze and assess what is the best long-term plan for administering programs like this and supporting the great organizations that it lifts up in our local rural SD communities.

#### New SD Ag Education Innovation & Leadership Grants through SDDA/SDAF Partnership

In addition to the work on item #2 above, we are also proposing to enhance the work of the current BOSDRC program by creating our own grant program to supplement this program with a focus on innovation and leadership in youth ag education. Attached is a draft program overview document and draft proposed grant application. We will fund this through an allocation of committed funds to the foundation from current donors that are available for operational and programmatic spending, First Dakota has committed to a partial reallocation of their commitment to support this effort, a possible match from SDDA and future matching dollars to grow the program coming from other potential foundation donors.

We will announce this plan for your approval in conjunction with existing communications that the South Dakota Department of Agriculture has in place for the BOSDRC grants, and then will target implementing and deploying this program in late Q4 2016/early Q1 2017.

#### SDAF- Ag Economic Development Best Practices Study and Proposed Solutions Development/Implementation

We would like to propose that the foundation takes on the funding and leadership of an Ag Economic Development Best Practices Study, to include the development of proposed solutions and identification of needed partnerships and organizations to deploy the proposed solutions. The Foundation would utilize both internal and external resources to complete the study. These efforts would include an analysis of the current resources available for Ag Development in South Dakota (current GOED and SDDA programs and other private sector programs), an identification of best practices and bright spots that have existed for ag development from both within and outside of the state of South Dakota, the development of a set of proposed options for enhanced ag economic development support programs for the state and finally, the engagement, organization and leadership of the ag industry stakeholders (SDDA, GOED, USDA, FSA, SD Ag Banking Industry leaders, Ag Venture Capital, and key individual ag producer leaders) that would be most directly connected with funding, administering and leading any of our proposed enhanced economic development efforts. We will announce and deploy this program in late Q4 2016/early Q1 2017.

#### SDAF – Philanthropy in Agriculture Program Development/Implementation

We would also like to propose that the foundation takes on the funding and leadership of a Philanthropy in Agriculture Program, to include the development of an action and engagement plan to spread the message of philanthropy throughout agriculture in South Dakota. We will develop the right message, channels for communication, target industry connectors and target stakeholders/donors. And then finally, we will utilize internal resources to identify best practices and bright spots in promoting philanthropy and foundations in agriculture and will use that information to develop a SMART (specific, measurable, actionable, realistic and timely) action plan to deploy these efforts in agriculture in South Dakota.

We believe that these two projects, in conjunction with the BOSDRC/SDAEI&L Grant Programs Partnerships, will give us focus as an organization, relevancy and engagement with stakeholders from across the industry and an excellent platform for engaging with current and future donors and supporters as we continue to fundraise and build the resources to support the long-term vision of the foundation. We will announce and deploy this program in late Q4 2016/early Q1 2017.
