Overview of Legislation



2023 South Dakota Legislature

House Bill 1017

Introduced by: The Joint Committee on Appropriations at the request of the Department of Corrections

An Act to authorize the Department of Corrections to purchase certain real property, to contract for the design of a prison facility for offenders committed to the Department of Corrections, to make an appropriation therefor, to transfer funds to the incarceration construction fund, and to declare an emergency.



Metrics: Overcrowded Facilities

SD State Correctional Facility	0	0	0	NA
Total	2453	2941	(488)	120%

- SD State Penitentiary is 176% over capacity.
- 488 more male offenders than what is safe & recommended by the American Correctional Association (ACA).

- HB 1017 would provide relief to all existing correctional facilities; all facilities would be under capacity.
- Increases available beds for male offenders, reduces & accounts for growth in population.
- Allows for proper custody classification.

Figure 4: Forecasted Population

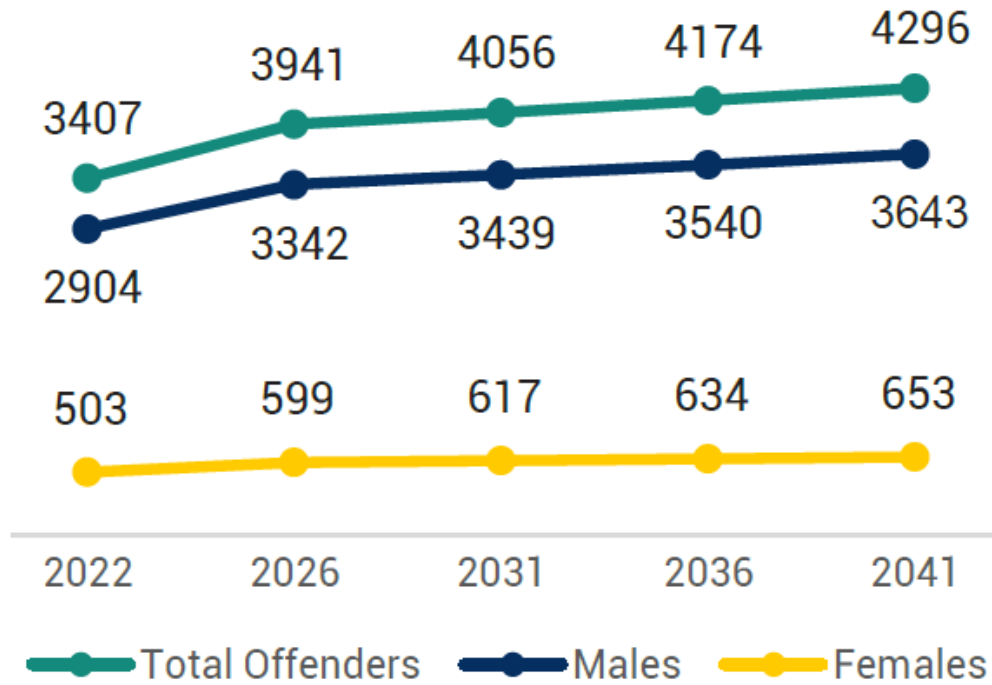
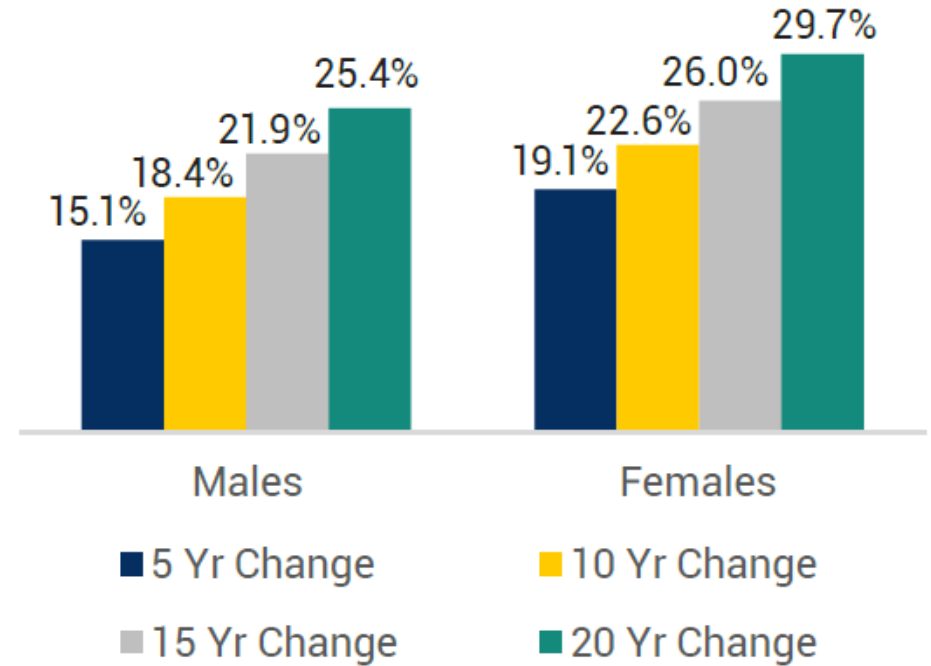


Figure 5: Forecasted Population Change



Metrics: Physical Plant Inefficiencies

- Intensive Staff Supervision Required
 - Multi-tiered, linear configuration is unsafe and inefficient to staff
 - Highest vacancy rate
 - Highest overtime & double time expenses
- Operational Inefficiencies
 - Built in 1881; 140-year-old building
 - \$30M spent on maintenance & repair since FY13
 - \$28.8M worth of identified projects that need to be addressed
 - Designed for single occupancy cells but house multiple offenders
 - Does not meet ACA standards

Project Description: Timeline

- March 2023: Legislative Approval of Phase I (land & design)
- Spring 2023: Purchase land & design work
 - *Includes hiring CMAR to develop construction strategy and budget
- March 2024/March 2025: Legislative Approval of Phase II (construction)

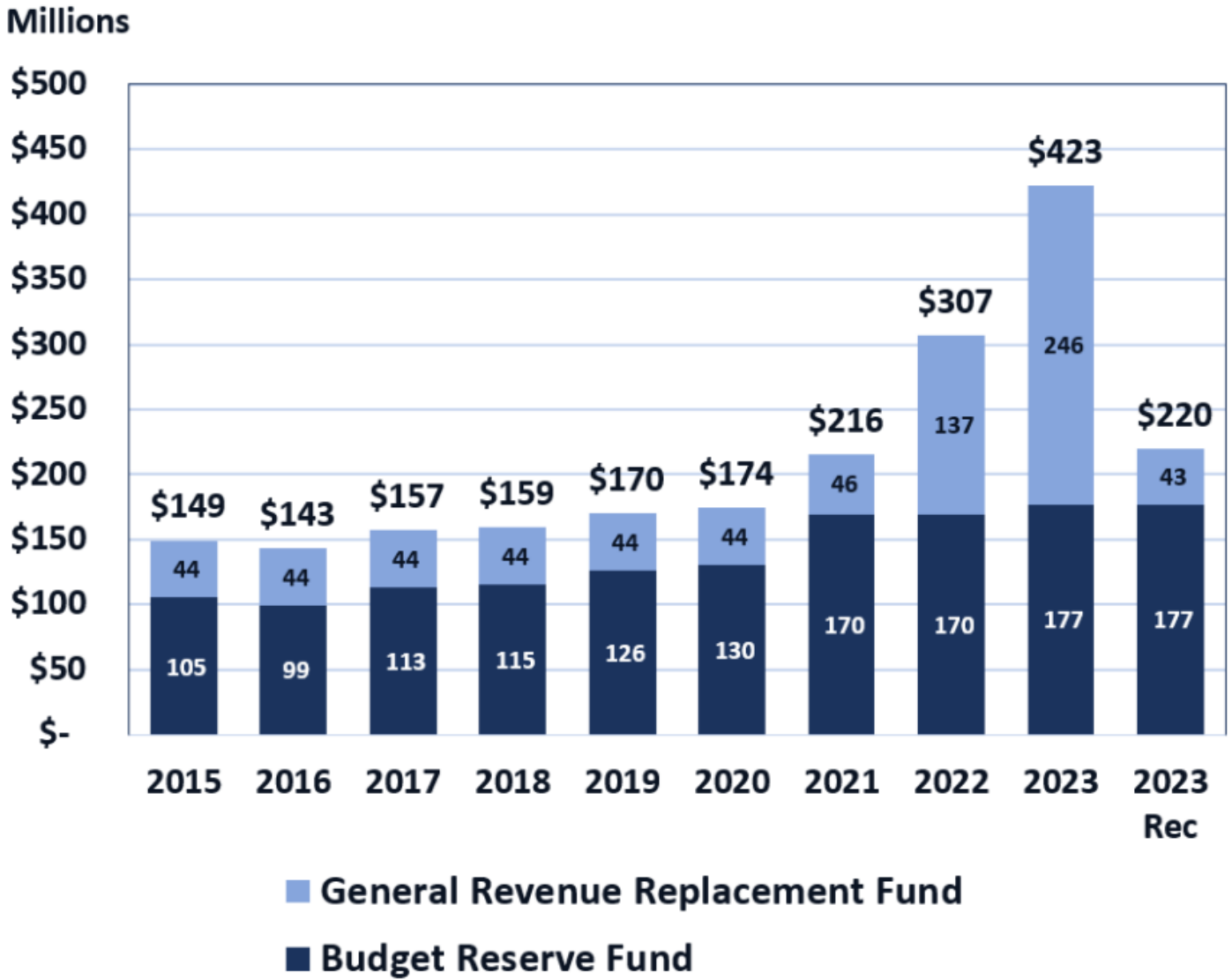
