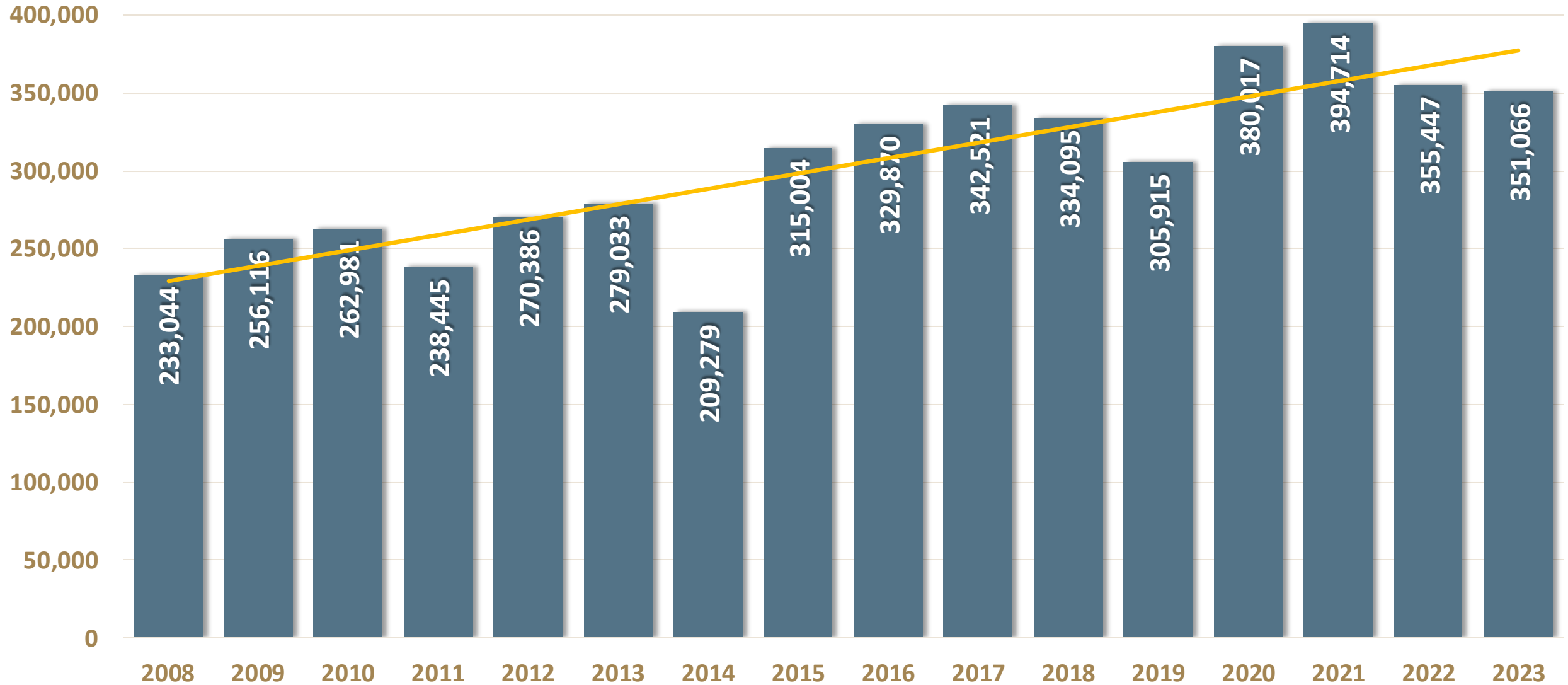

# GO OUTDOORS SOUTH DAKOTA

- Processed over 350,000 total applications in 2023
  - Over 40,000 first draw elk applications
  - Over 72,000 first draw deer applications
- Generated over \$60 million in total revenue in 2023
- Over 2.3 million transactions completed since inception.
- To make this system more efficient and customer-friendly, work will continue in 2024.

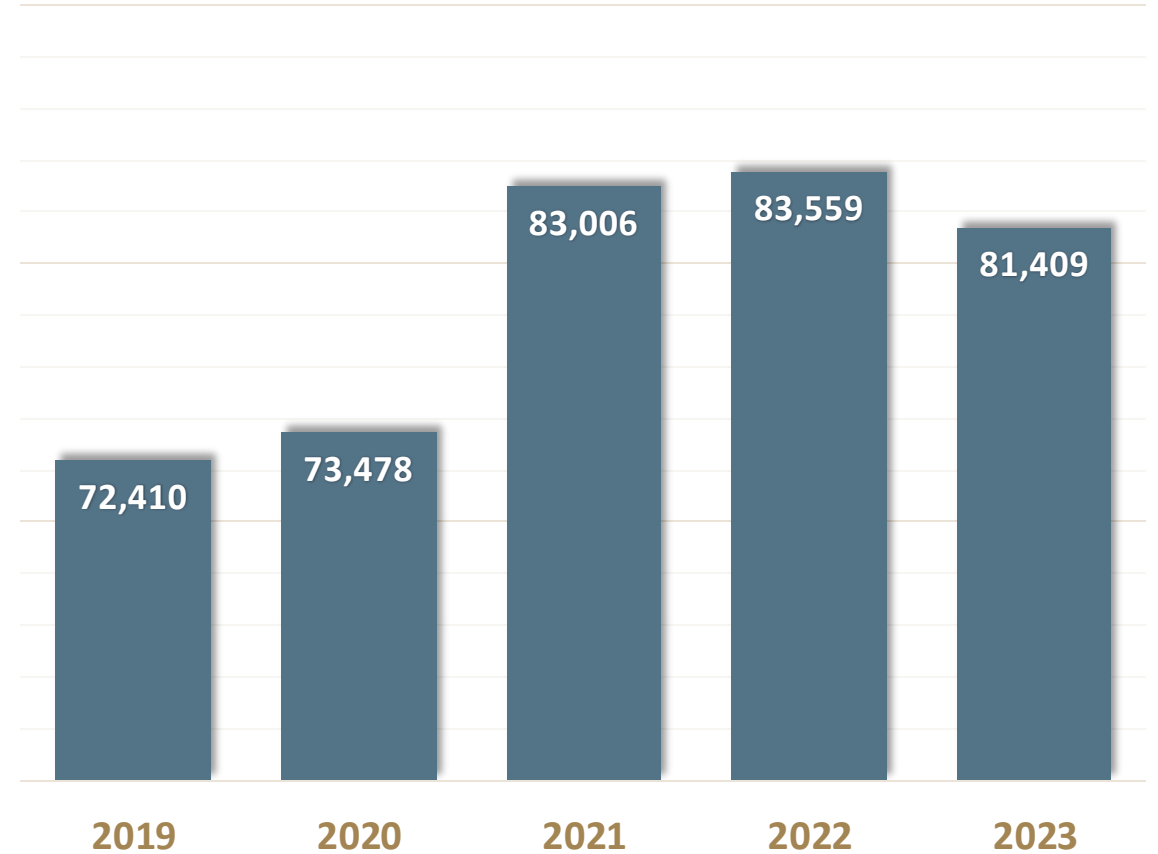

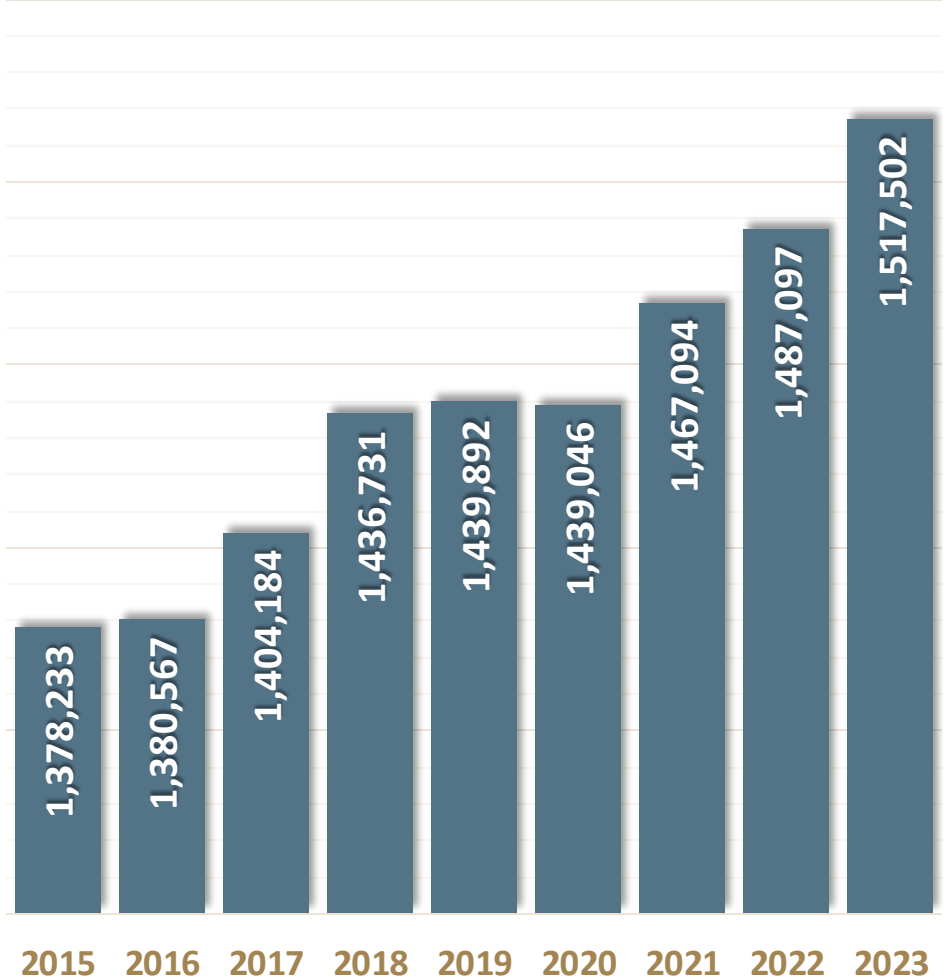

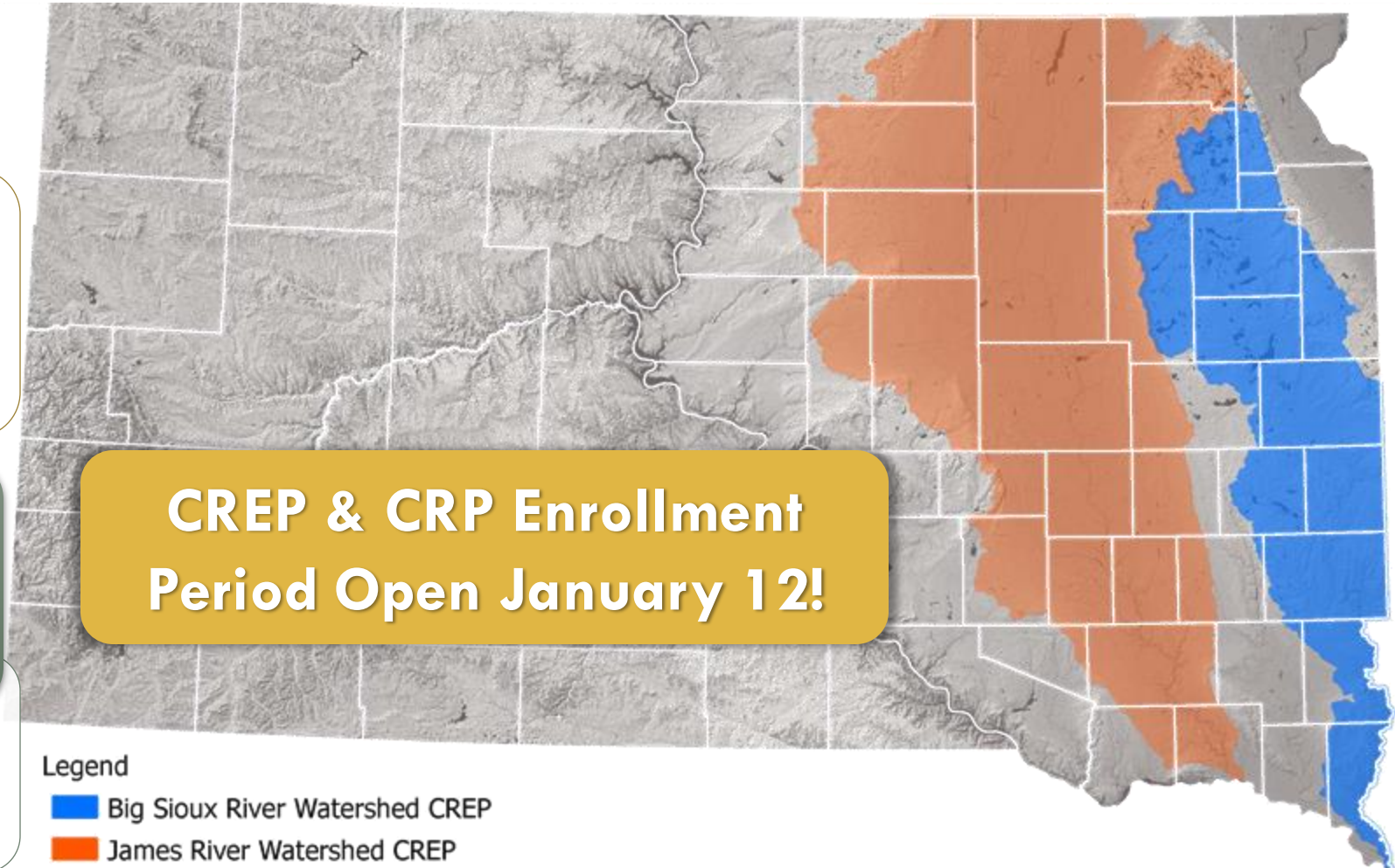

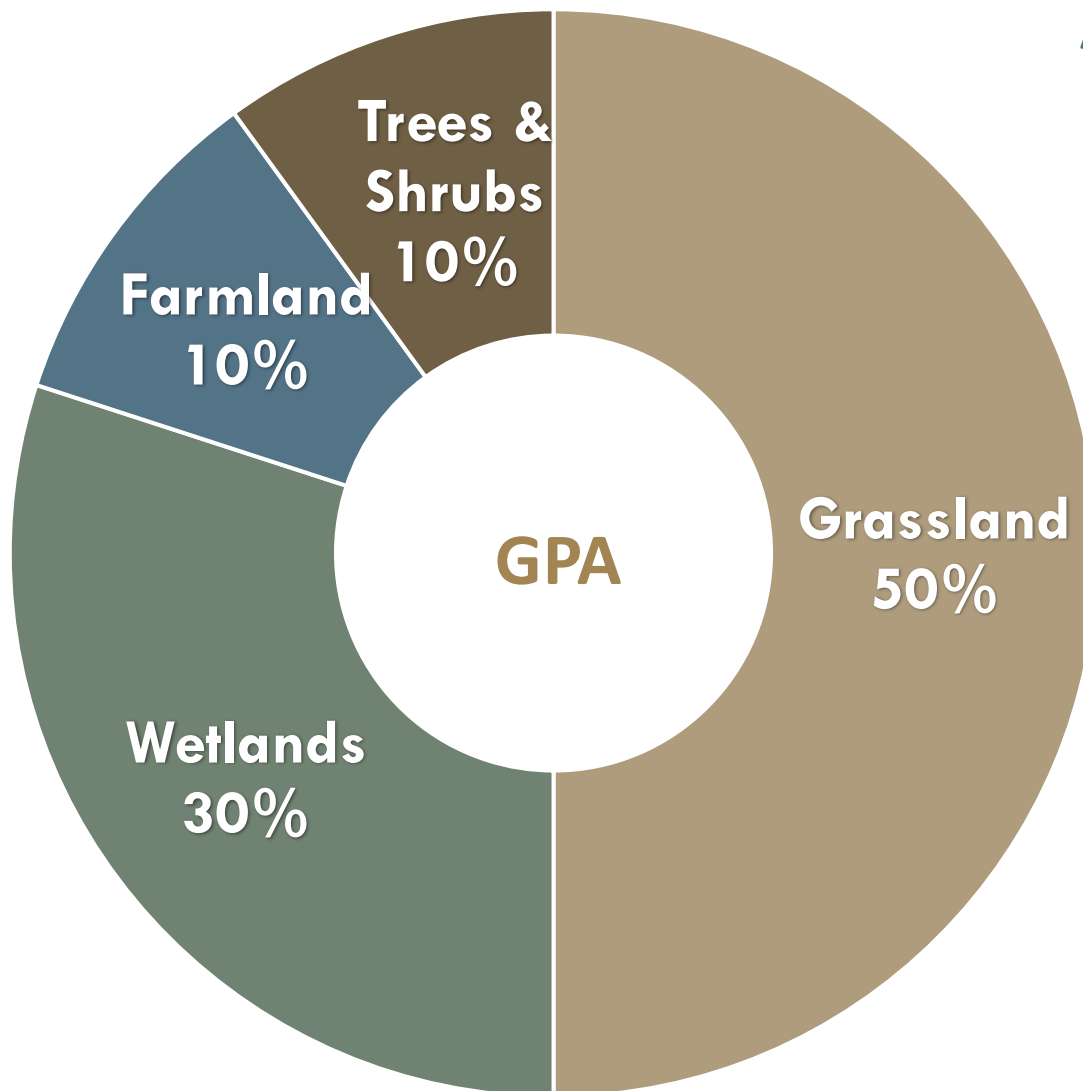

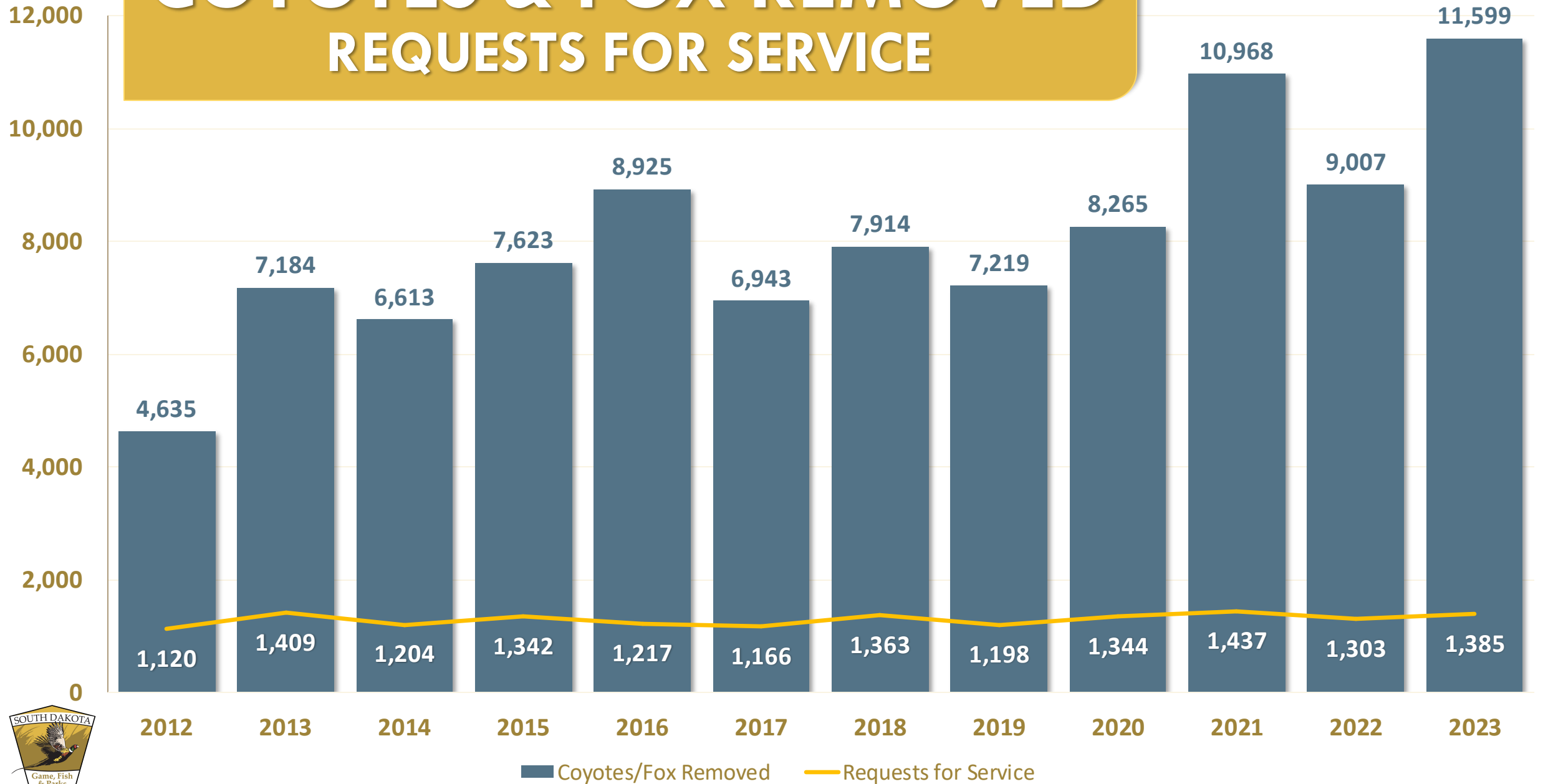

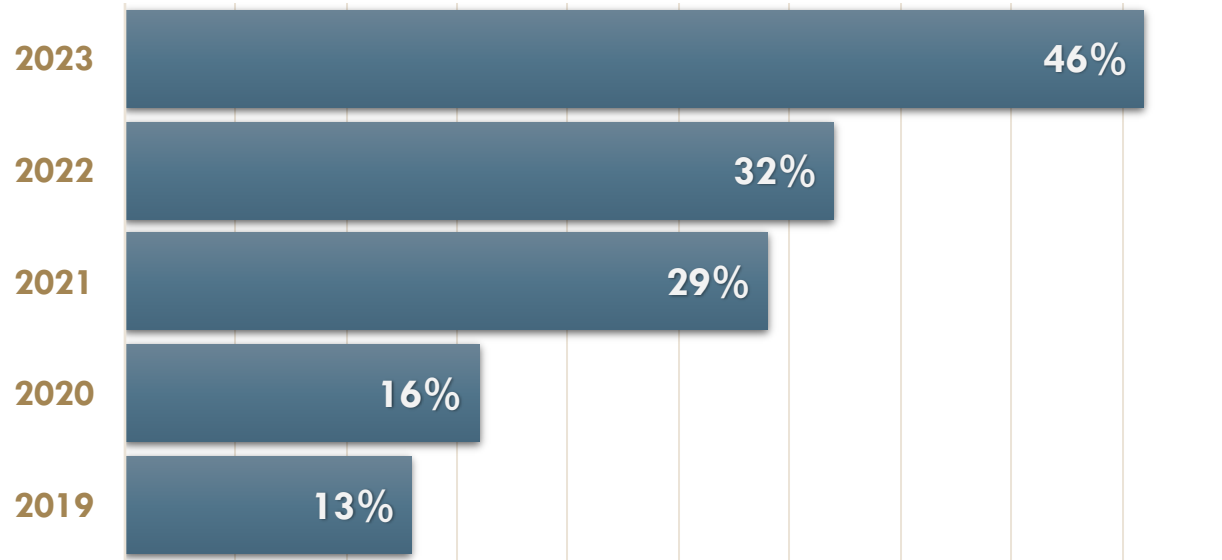

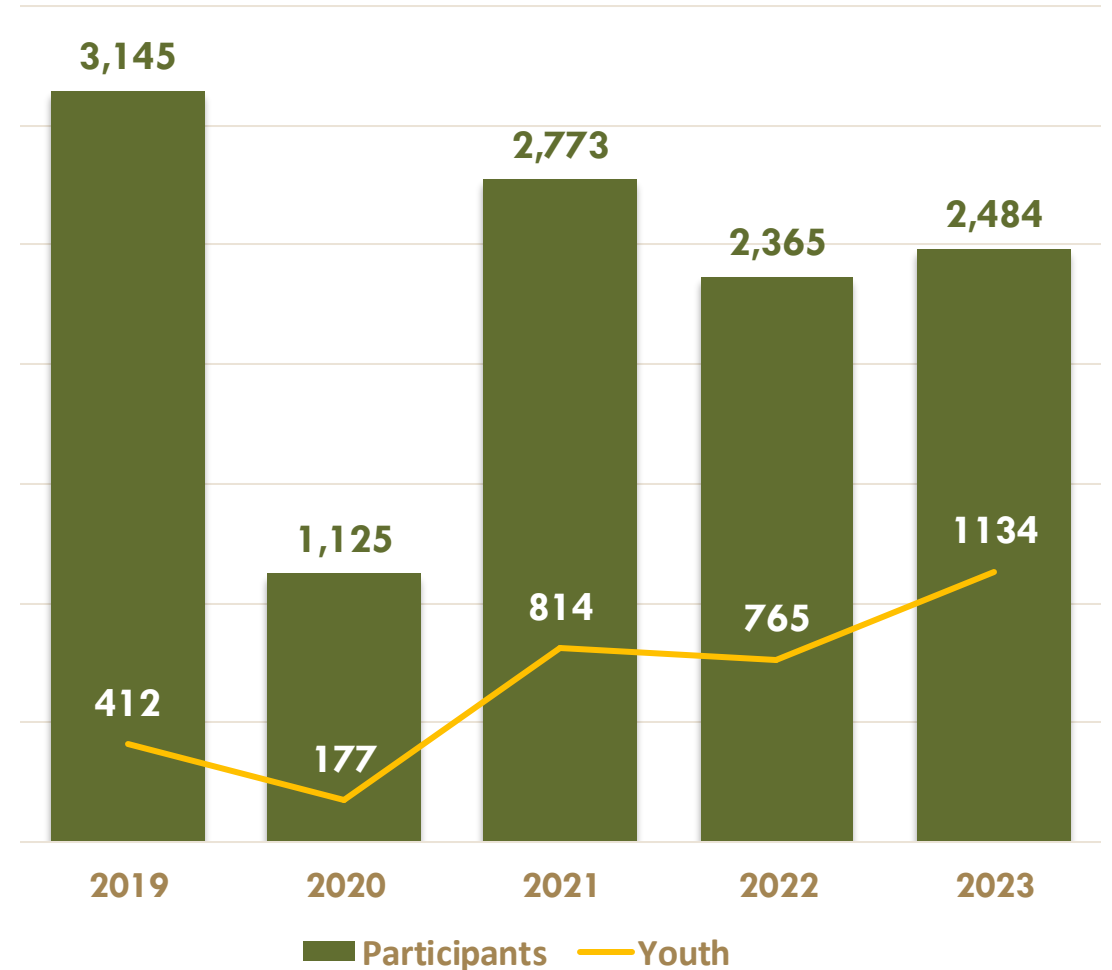

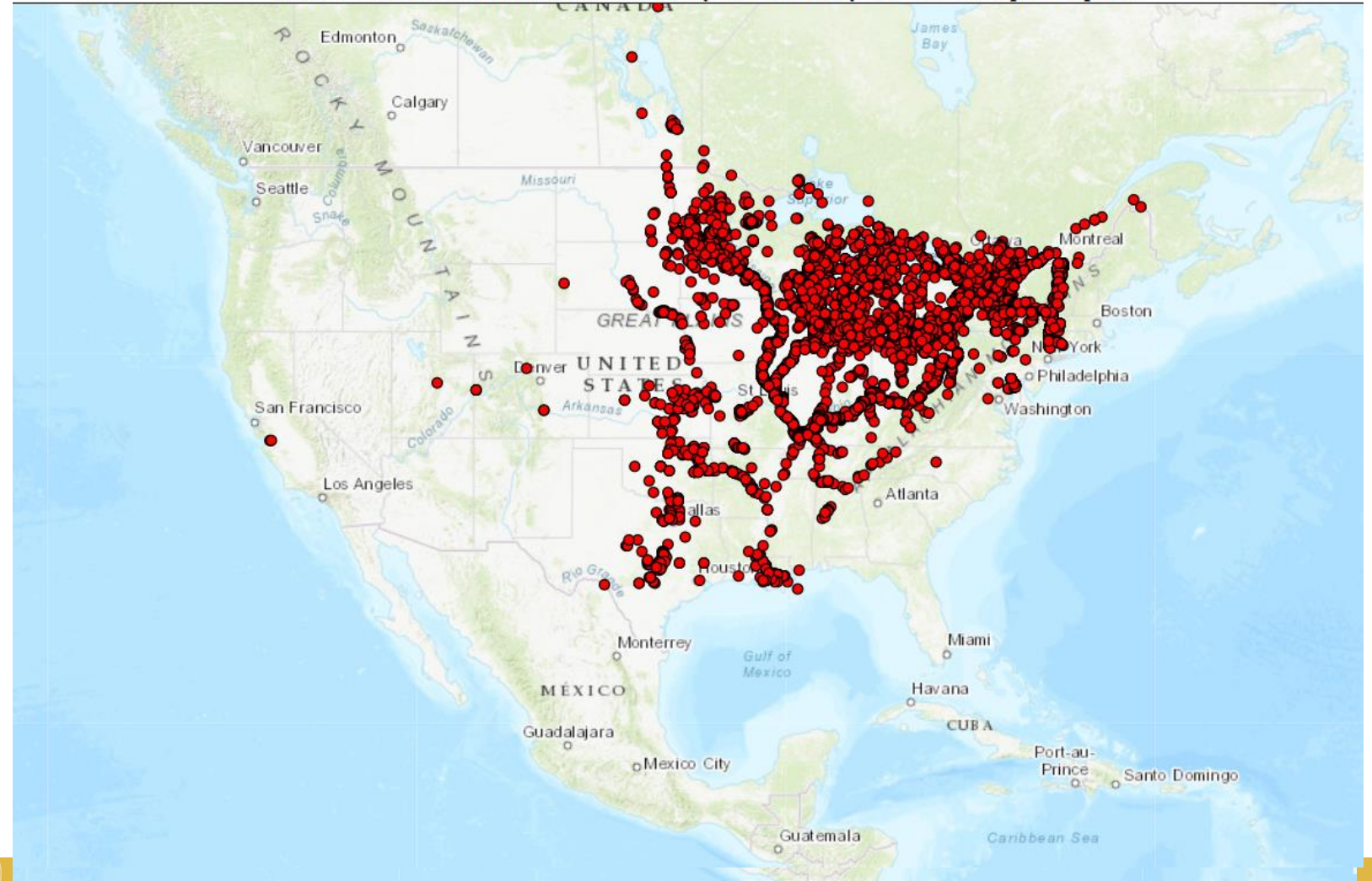

## PROJECT TIMELINE

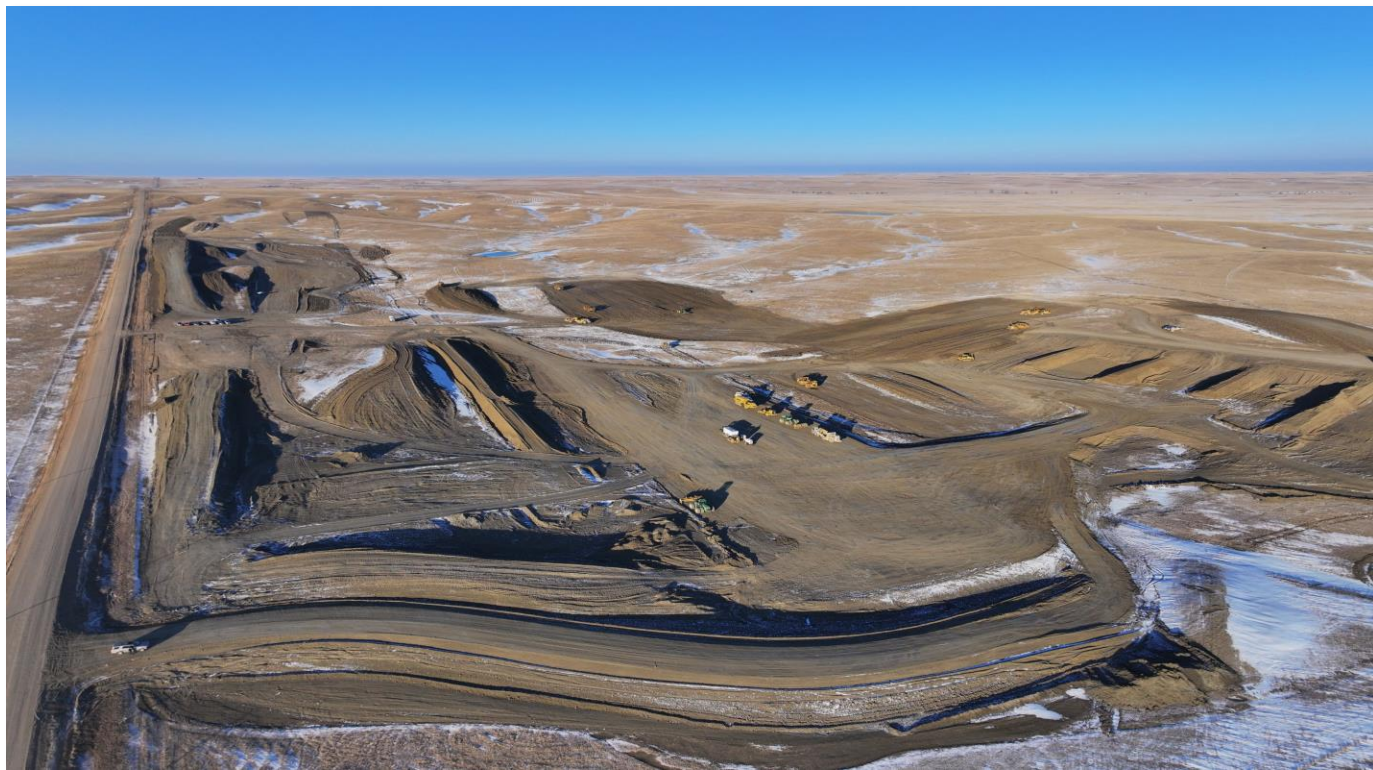
Construction has started

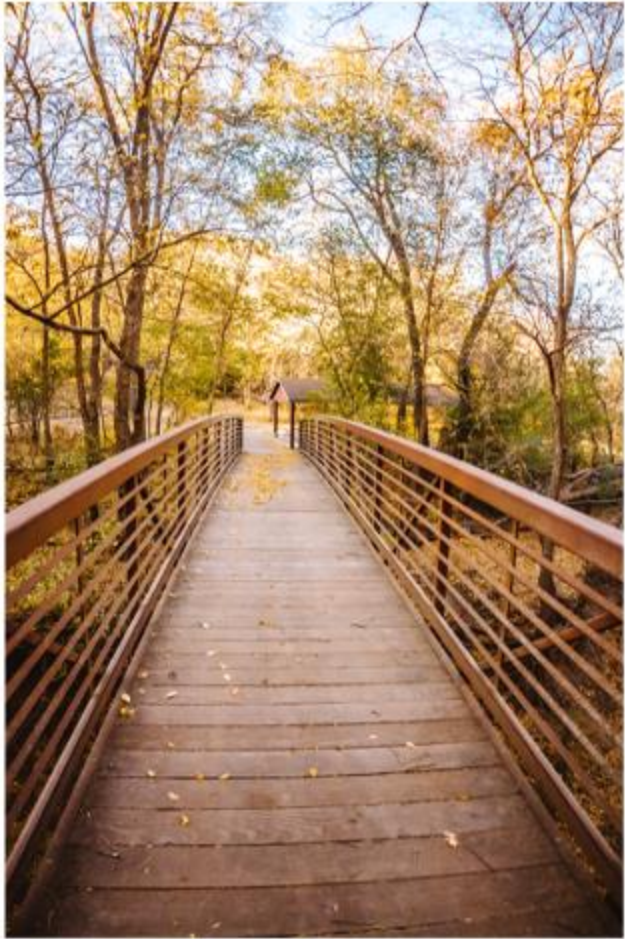


# PARKS BY THE NUMBERS
