1 FOR AN ACT ENTITLED, An Act to enhance education in the state and to make an
2 appropriation therefor.

3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF SOUTH DAKOTA:

4 Section 1. There is hereby created the teacher compensation assistance program within the
5 Department of Education to provide funds to school districts for the purpose of assisting school
6 districts with teacher compensation. School districts are eligible to receive funds from the
7 teacher compensation assistance program based on their fall enrollment numbers. The
8 department shall provide four-fifths of the funds for the teacher compensation assistance
9 program to each participating school district. The Board of Education shall promulgate rules,
10 pursuant to chapter 1-26, to create an oversight board appointed by the secretary of education
11 for approval of applications as well as guidelines for district applications based on district
12 instructional goals, market compensation or other specific district requirements as approved by
13 the department. Participation in the program is discretionary. District applications shall be
14 approved by the local board of education. The applications shall be reviewed by the teacher



1 compensation assistance program oversight board and shall be recommended to the Board of
2 Education for final approval.

3 The Legislature shall review the teacher compensation assistance program in 2012 to
4 determine its effectiveness and to determine whether to continue the program.

5 Section 2. The Teacher Compensation Assistance Program Oversight Board shall annually
6 monitor the progress of participating school districts with their teacher compensation assistance
7 plans, and submit its findings to the Board of Education.

8 Section 3. The South Dakota Board of Education shall promulgate rules pursuant to chapter
9 1-26 establishing the application process; application timelines; the guidelines for district
10 applications based on school district instructional goals or market compensation; and a system
11 to monitor the progress of participating school districts with their compensation assistance plans
12 and to ensure that each participating school district is complying with the plan as submitted to
13 the board.

14 Section 4. The secretary of the Department of Education shall establish seven education
15 service agencies to provide services and leadership to school districts on a regional basis. Each
16 education service agency shall serve the school districts in a particular region of the state as
17 determined by the secretary of education, and the secretary shall ensure that every school district
18 is served by an education service agency. Each education service agency may be incorporated
19 in the state of South Dakota as a nonprofit corporation organized under chapters 47-22 to 47-28,
20 inclusive, which is exempt from taxation pursuant to 501(a) of the Internal Revenue Code, 26
21 U.S.C. Section 501(a), and may be listed as an exempt organization in Section 501(c) of the
22 Internal Revenue Code, 26 U.S.C. Section 501(c), or an education service agency may be
23 directed by an educational cooperative.

24 Section 5. Education service agencies are hereby authorized and empowered to develop,

1 manage, and provide support services and programs as determined by the needs of the local
2 school districts and as approved by the secretary of education. An education service agency may:

- 3 (1) Act primarily as a service agency in providing services and programs as identified
4 and requested by the school districts it serves, including professional development,
5 instructional materials, educational technology, curriculum development, and
6 alternative educational programs;
- 7 (2) Provide for economy, efficiency, and cost effectiveness in the cooperative delivery
8 and purchase or lease of educational services, materials, and products; the services
9 may include purchasing cooperatives, insurance cooperatives, business management
10 services, auditing and accounting services, school safety and risk prevention training,
11 data processing, and assistance with student records;
- 12 (3) Provide administrative services such as communications and public relations
13 services, employee background checks, grants management services, printing and
14 publication services, and internship services;
- 15 (4) Provide educational services through leadership and research and development in
16 elementary and secondary education;
- 17 (5) Work cooperatively with the Department of Education, institutions of higher
18 education, local school districts, and other educational organizations to support,
19 develop, and implement long-range plans and strategic goals for the enhancement of
20 educational opportunities in elementary and secondary education; and
- 21 (6) Serve, when appropriate and if funds are available, as a repository, clearinghouse,
22 and administrator of federal, state, local, and private funds on behalf of school
23 districts that may participate in special programs, projects, or grants in order to
24 enhance the quality of education in South Dakota schools.

1 Section 6. Each education service agency shall have an advisory board. The advisory board
2 shall meet at least twice a year, and its membership shall include the superintendent or a
3 designee of the superintendent from every school district served by the agency. The advisory
4 board shall provide guidance to the agency relative to the needs of the school districts and how
5 the education service agency might address those needs.

6 Section 7. Beginning in 2008, the advisory board for each education service agency shall,
7 upon receiving the approval of the secretary of education, appoint a fiscal agent to oversee the
8 daily operations of the education service agency. Once appointed, the fiscal agent shall serve
9 at the pleasure of the board. However, a board's decision to rescind a fiscal agent's appointment
10 shall be approved by the secretary of education.

11 Section 8. A statewide leadership board, composed of the fiscal agent from each education
12 service agency and a representative from the Department of Education, shall be created to
13 establish uniform policies among the education service agencies and to allow for
14 communication and the exchange of ideas.

15 Section 9. Upon receiving approval from the Department of Education, each education
16 service agency, with input from both the advisory board and the statewide leadership board,
17 may, as funding permits, contract with other entities to provide services to the school districts
18 it serves.

19 Section 10. Each year, the Department of Education shall conduct an assessment and a
20 performance evaluation of each education service agency and submit its findings in writing to
21 the Legislature.

22 Section 11. The South Dakota Board of Education shall promulgate rules pursuant to chapter
23 1-26 establishing the evaluation process and the criteria and performance measures the
24 department will use to evaluate the education service agencies.

1 Section 12. The secretary of the Department of Education shall approve vouchers and the
2 state auditor shall draw warrants to pay expenditures authorized by this Act.

3 Section 13. For the fiscal year beginning on July 1, 2007, there is hereby appropriated from
4 the education enhancement tobacco tax fund the sum of nine million dollars (\$9,000,000), or
5 so much thereof as may be necessary, to the Department of Education and shall be distributed
6 as follows:

7 (1) Four million dollars for the teacher compensation assistance program created in
8 section 3 of this Act;

9 (2) One million seven hundred thousand dollars for the education service agencies
10 established in section 4 of this Act;

11 (3) One million five hundred thousand dollars for career and technical education
12 programs;

13 (4) One million eight hundred thousand dollars to apply to any increases in the total cost
14 of foundation program state aid or other educational programs that resulted from
15 legislation enacted during the Eighty-Second Session of the South Dakota Legislature
16 based on the findings of the two-year study of school funding that was undertaken by
17 the Department of Education in 2005; and

18 Section 14. For the fiscal year beginning on July 1, 2008 and for each fiscal year thereafter,
19 the secretary of education shall expend nine million dollars of the monies deposited in the
20 education enhancement tobacco tax fund through the normal budget process as set forth in § 4-
21 7-9. Expenditures from the fund shall support the following education programs:

22 (1) The teacher compensation assistance program created in section 3 of this Act;

23 (2) The education service agencies established in section 4 of this Act;

24 (3) Career and technical education programs; and

1 (4) Other education program expenditures as set forth by the Legislature.

2 Section 15. For the fiscal year beginning on July 1, 2007, there is hereby appropriated from
3 the general fund the sum of five million dollars (\$5,000,000) to the Department of Education
4 for distribution to school districts through the state aid to general education foundation formula.
