- 1 FOR AN ACT ENTITLED, An Act to provide that salvage titles be issued for stolen vehicles
- and to provide that thefts be noted on the title of recovered motor vehicles.
- 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF SOUTH DAKOTA:
- 4 Section 1. That § 32-3-51.19 be amended to read as follows:
- 5 32-3-51.19. For purposes of §§ 32-3-51.5, 32-3-51.9, 32-3-51.19, 32-3-51.20, and 32-3-
- 6 51.21, the term, salvage vehicle, means any motor vehicle as defined in § 32-3-51.10 that an
- 7 insurer or self insurer determines a total loss due to theft or to damage caused by fire, vandalism,
- 8 collision, weather, submersion in water, or flood. This section does not apply to any motor
- 9 vehicle more than six model years old or with a gross vehicle weight rating of more than sixteen
- thousand pounds.
- 11 Section 2. That chapter 32-3 be amended by adding thereto a NEW SECTION to read as
- 12 follows:
- If a stolen vehicle is recovered, the insurer or self insurer shall, within thirty days of
- recovery, inspect the vehicle and apply for a title as follows:

1	(1)	If the vehicle has no damage or the damage is less than that defined in § 32-3-51.8,
2		surrender the existing salvage title to the department. The department shall promptly
3		issue a title marked as a recovered theft with no damage disclosure notation pursuant

5	(2)	If the vehicle has damage equal to or greater than that defined in § 32-3-51.8,
6		surrender the existing salvage title to the department. The department shall promptly
7		issue a title marked as a recovered theft with the damage disclosure notation pursuant
8		to § 32-3-51.8.
9	Howe	ever, if the condition of the vehicle is such that it would have been determined a
10	salvage vehicle as defined in § 32-3-51.19 due to the damage to the vehicle, the salvage title is	
11	retained a	and the insurer or self insurer is not required to apply for a title pursuant to this section.
