

2025 South Dakota Legislature House Bill 1256

1	An Act to require the inclusion of certain information on a candidate's nominating
2	petition or on a ballot question petition.
3	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF SOUTH DAKOTA:

4	Section 1. That § 2-1-1 be AMENDED:
5	2-1-1. All measures proposed by initiative-shall must be presented by petition.
6	The A petition shall to propose a measure by initiative must be signed by not less than
7	five percent of the qualified electors of the state.
8	All proposals requiring that a law enacted by the Legislature be submitted to a vote
9	of the electors of the state must be presented by petition, signed by not less than five
10	percent of the qualified electors of the state.
11	When signing a petition to propose a measure or an amendment to the Constitution
12	by initiative, or to refer a law to a vote of the electors of the state, an individual must
13	provide the individual's name, signature, address at which the individual is currently
14	registered to vote, the county in which the individual is registered as a voter, and the date
15	of signing.

17	2-1-15. Upon the receiving of any initiative petition, referred law petition, or
18	initiated constitutional amendment petition receipt of a petition to initiate an amendment

21	petition signatures and make them available to the public upon request and payment of
22	reasonable fees in accordance with the fee required by § 1-8-10. No

An individual's signature of a person may not be counted by the secretary of state
unless the person if:

1	(1) The individual is not a registered voter in the county indicated on the signature
2	line . No signature of a person may be counted if the; or
3	(2) The information-required provided by the individual on the petition form is not
4	accurate or complete.
5	If the address provided by the individual is not substantially the same as the
6	address at which the individual is currently registered to vote, the secretary of state may
7	not count the signature.
8	The secretary of state shall generate the random sample under § 2-1-16 within
9	five days of completing the examination and cataloguing of the petition signatures and
10	<u>shall</u> make <u>the random sample validation sheets</u> available to the public the random sample
11	validation sheets, upon request and payment of reasonable fees in accordance with the
12	fee required by § 1-8-10.

14	12-6-8. No person An individual may not sign the nominating petition of a
15	candidate before:
16	(1) Before January first in the year in which the election is to be held, nor for;
17	(2) For whom the person is not entitled to vote, nor for;
18	(3) For a political candidate of a party of which the person is not a member, nor for;

20	(4) For more than the number of candidates required to be nominated for the same
21	office.
22	The signer or circulator or the individual who signs the petition shall add the
23	signer's place of residence address at which the individual is currently registered to vote,
24	the county in which the individual is registered as a voter, and the date of signing. The
25	signer's post office box number may be given in lieu of a street address if the signer lives
26	within a municipality of the second or third classA
27	<u>A candidate shall sign a</u> formal declaration of the candidate shall be signed by the
28	candidate candidacy before the circulation of petitions petition may be circulated. The
29	signed declaration of the candidate shall candidacy must accompany and be a part of the
30	petition An_The original signed declaration- shall_of candidacy_must accompany the -group
31	of petitions petition upon filing.
32	The petition <u>-shall must</u> be verified under oath by the persons circulating the
33	petition. The verification by the person circulating the petition may not be notarized by

the candidate whom the petition is nominating. Any person circulating a petition who
falsely attests to the verification is guilty of a Class 6 felony.

A nominating petition for any election shall be a self-contained sheet of paper in order to have the candidate's name placed on the ballot. The provisions of this section may not prohibit a person registered with party affiliation from signing either a petition nominating an independent or a nonpolitical candidate for office if the person has not previously signed a petition for that office to be filled.
