1 FOR AN ACT ENTITLED, An Act to establish a target teacher salary and a target teacher ratio, 2 to revise certain provisions regarding education funding, to create the School Finance Accountability Board, and to provide for certain school district reporting and penalties. 3 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF SOUTH DAKOTA: 5 Section 1. That § 13-10-6 be repealed. 6 13-10-6. For the purpose of continuing a fund for the payment of pensions to retired 7 employees of a school district that has established such system, the school district may levy an 8 annual tax not exceeding thirty cents per thousand dollars of taxable valuation of the school 9 district for the current year. The levy may not be included in determining the tax levy limitation 10 of the school district provided by law. Moneys collected from the tax shall be kept by the 11 business manager in a special pension fund and may not be used for any other purpose except 12 upon discontinuance of the pension system by the school district, in which case any unexpended 13 balance shall be transferred to the general fund.

For taxes payable in 2011, the total amount of revenue payable from the levy provided in

After applying the index factor, a school district may increase the revenue payable from 14 taxes on real property above the limitations provided by this section by the percentage increase 15 of value resulting from any improvements or change in use of real property, annexation, minor 16 boundary changes, and any adjustments in taxation of real property separately classified and 17 subject to statutory adjustments and reductions under chapters 10-4, 10-6, 10-6A, and 10-6B, 18 except § 10-6-31.4, only if assessed the same as property of equal value. 19 Any school district created or reorganized after January 1, 2009, is exempt from the 20 limitation provided by this section for a period of two years immediately following its creation. 21 For taxes payable in 2011, 2012, 2013, 2014, and 2015, the levy limitation of thirty cents 22 per thousand dollars of taxable valuation does not apply to any school district. 23 Section 2. Section 1 of this Act is effective on January 1, 2017.

During the period of time beginning on July 1, 2009, and ending on June 30, 2018, any A school district may make payments transfer from its capital outlay fund for the purchase of property insurance and casualty insurance, for payments for energy costs and the cost of utilities, and for motor fuel or for any portion of a contract providing transportation to students or for any mileage reimbursements. However, the total amount that a school district expends from its capital outlay fund for these expenses may to its general fund an amount not to exceed forty-five percent of the total tax revenues deposited in that fund during the current school fiscal year, and for any school district with a current tax levy for the capital outlay fund that is greater than its tax levy for the capital outlay fund in school fiscal year 2008, the total amount expended from the capital outlay fund for these expenses may not exceed forty-five percent of the total tax revenues that would have been deposited in that fund during the current school fiscal year if the
