## SENATE JOINT RESOLUTION NO. 3

- 1 A JOINT RESOLUTION, To apply for a convention of states under Article V of the
- 2 Constitution of the United States to impose fiscal restraints on the federal government and
- 3 limit the power and jurisdiction of the federal government.
- 4 BE IT RESOLVED BY THE SENATE OF THE STATE OF SOUTH DAKOTA, THE HOUSE
- 5 OF REPRESENTATIVES CONCURRING THEREIN:
- 6 WHEREAS, the founders of the Constitution empowered state legislators to be guardians
- 7 of liberty against the future abuses of power by the federal government; and
- 8 WHEREAS, the federal government has created a crushing national debt through improper
- 9 and imprudent spending; and
- WHEREAS, the federal government has invaded the legitimate roles of the state through the
- manipulative process of federal mandates, most of which are unfunded to a great extent; and
- WHEREAS, the federal government has ceased to live under a proper interpretation of the
- 13 Constitution of the United States; and
- WHEREAS, it is the solemn duty of the states to protect the liberty of our people,

1 particularly for the generations to come, by proposing amendments to the Constitution of the 2 United States through a convention of the states under Article V for the purpose of restraining 3 these and related abuses of power: 4 NOW, THEREFORE, BE IT RESOLVED, by the Senate of the Ninety-third Legislature of 5 the State of South Dakota, the House of Representatives concurring therein, that the Legislature 6 of the State of South Dakota hereby applies to Congress, under the provisions of Article V of 7 the Constitution of the United States, for the calling of a convention of the states limited to 8 proposing amendments to the Constitution of the United States that impose fiscal restraints on 9 the federal government, limit the power and jurisdiction of the federal government, and limit 10 the terms of office for federal officials and for members of Congress; and 11 BE IT FURTHER RESOLVED, that the secretary of state is hereby directed to transmit 12 copies of this application to the President and Secretary of the United States Senate and to the 13 Speaker and Clerk of the United States House of Representatives; and copies to the members 14 of the United States Senate and House of Representatives from this state; and also to transmit 15 copies to the presiding officers of each of the legislative houses in the several states, requesting 16 their cooperation; and 17 BE IT FURTHER RESOLVED, that this application constitutes a continuing application 18 in accordance with Article V of the Constitution of the United States until the legislatures of at 19 least two-thirds of the several states have made applications on the same subject; and 20 BE IT FURTHER RESOLVED, that the Legislature adopts this application expressly 21 subject to the following reservations, understandings, and declarations: 22 (1) An application to the Congress of the United States to call an amendment convention 23 of the states pursuant to Article V of the United States Constitution confers no power

to Congress other than the power to call the convention. The power of Congress to

| 12 | (4) | By definition, an amendment convention of the states means that states shall vote on   |
| 13 |     | the basis of one state, one vote;  |
| 14 | (5) | A convention for proposing amendments convened pursuant to this application must       |
| 15 |     | be limited to consideration of the topics specified herein and no other. This          |
| 16 |     | application is made with the express understanding that an amendment that in any       |
| 17 |     | way seeks to amend, modify, or repeal any provision of the Bill of Rights is not       |
| 18 |     | authorized for consideration at any stage. This application is void ab initio if ever  |
| 19 |     | used at any stage to consider any change to any provision of the Bill of Rights;       |
| 20 | (6) | Pursuant to Article V of the United States Constitution, Congress may determine        |
| 21 |     | whether proposed amendments must be ratified by the legislatures of the several        |
| 22 |     | states or by special state ratification conventions. The Legislature recommends        |
| 23 |     | Congress select ratification by the legislatures of the several states; and            |
