- 3 Section 43. The state treasurer shall transfer to the state general fund the sum of ninety-
- 4 two thousand six hundred dollars (\$92,600) from the special racing revolving fund.
- 5 Section 44. The state treasurer shall transfer to the state general fund the sum of twenty-
- 6 seven thousand four hundred dollars (\$27,400) from the South Dakota-bred racing fund.
- 7 **Section 22.** Funds appropriated by this Act which are unspent at the end of fiscal year 2020
- 8 may be carried over to fiscal year 2021.
- 9 **Section 23.** This Act is effective June 29, 2020.
