# Senate Bill 193 ENROLLED

An Act

ENTITLED An Act to revise Senate Bill 38, An Act to revise the General Appropriations Act for fiscal year 2020, as previously enacted by the Ninety-fifth Session of the South Dakota Legislature.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF SOUTH DAKOTA:

**Section 1.** That section 1 of SB 38 as previously enacted by the Ninety-fifth Session of the South Dakota Legislature be amended to read:

BUREAU OF FINANCE AND MANAGEMENT (BFM):

(2) Computer Services and Development

Operating Expenses, Federal Funds, delete "\$0" and insert "\$55,760,060"

**Section 2.** That section 6 of Senate Bill 38, as previously enacted by the Ninety-fifth Session of the South Dakota Legislature, be amended to read:

DEPARTMENT OF SOCIAL SERVICES

(3) Medical Services

Operating Expenses, General Funds, delete "\$226,699,293" and insert "\$214,421,877"

Operating Expenses, Federal Funds, delete "\$425,719,070" and insert "\$424,773,394"

(4) Children's Services

Operating Expenses, General Funds, delete "\$37,042,841" and insert "\$34,892,841"

Operating Expenses, Federal Funds, delete "\$44,243,920" and insert "\$49,598,663"

(5) Behavioral Health

Operating Expenses, General Funds, delete "\$59,889,875" and insert "\$57,714,191"

Operating Expenses, Federal Funds, delete "\$33,721,971" and insert "\$34,894,940"

**Section 3.** That section 7 of Senate Bill 38, as previously enacted by the Ninety-fifth Session of the South Dakota Legislature, be amended to read:

(2) Health Systems Development and Regulation

Operating Expenses, Federal Funds, delete "\$7,284,070" and insert "\$8,821,797"

Operating Expenses, Other Funds, delete "\$1,156,540" and insert "\$4,826,881"

(3) Family and Community Health

Personal Services, Federal Funds, delete "\$10,600,921" and insert "\$10,800,921"

Operating Expenses, General Funds, delete "\$2,036,929" and insert "\$2,111,929"

Operating Expenses, Federal Funds, delete "\$16,717,088" and insert "\$19,039,755"

**Section 4.** That section 8 of SB 38, as previously enacted by the Ninety-fifth Session of the South Dakota Legislature, be amended to read:

## DEPARTMENT OF LABOR AND REGULATION

(2) Unemployment Insurance Service

Personal Services, Federal Funds, delete "\$4,149,185" and insert "\$5,758,187"

Operating Expenses, Federal Funds, delete "\$2,637,079" and insert "\$4,832,839"

FTE, delete "72.0" and insert "82.0"

**Section 5.** That section 10 of SB 38, as previously enacted by the Ninety-fifth Session of the South Dakota Legislature, be amended to read:

# DEPARTMENT OF EDUCATION

(11) Education Resources

Operating Expenses, General Funds, delete "\$8,716,179" and insert "\$7,898,678"

Operating Expenses, Federal Funds, delete "\$175,481,630" and insert "\$175,491,423"

Operating Expenses, Other Funds, delete "\$604,572" and insert "\$1,354,572"

**Section 6.** That section 14 of SB 38, as previously enacted by the Ninety-fifth Session of the South Dakota Legislature, be amended to read:

# DEPARTMENT OF VETERANS AFFAIRS

(2) State Veterans' Home

Operating Expenses, Federal Funds, delete "\$0" and insert "\$191,884"

Operating Expenses, Other Funds, delete "\$3,329,930" and insert "\$3,203,367"

**Section 7.** That section 15 of SB 38, as previously enacted by the Ninety-fifth Session of the South Dakota Legislature, be amended to read:

## **DEPARTMENT OF CORRECTIONS**

(8) Juvenile Community Corrections

Operating Expenses, Federal Funds, delete "\$3,356,457" and insert "\$3,537,221"

**Section 8.** That section 16 of Senate Bill 38, as previously enacted by the Ninety-fifth Session of the South Dakota Legislature, be amended to read as follows:

#### DEPARTMENT OF HUMAN SERVICES

(2) Developmental Disabilities

Operating Expenses, General Funds, delete "\$63,311,136" and insert "\$64,311,136"

Operating Expenses, Federal Funds, delete "\$92,214,209" and insert "\$98,151,680"

(3) South Dakota Developmental Center - Redfield

Personal Services, General Funds, delete "\$8,434,038" and insert "\$7,802,981"

Personal Services, Federal Funds, delete "\$11,404,984" and insert "\$11,163,630"

Operating Expenses, General Funds, delete "\$2,291,015" and insert "\$2,277,423"

Operating Expenses, Federal Funds, delete "\$2,903,362" and insert "\$3,077,245"

(4) Long Term Services and Supports

Operating Expenses, General Funds, delete "\$93,667,385" and insert "\$90,886,944"

Operating Expenses, Federal Funds, delete "\$127,243,759" and insert "\$130,854,219"

(5) Rehabilitation Services

Operating Expenses, Federal Funds, delete "\$13,343,669" and insert "\$13,508,241"

**Section 9.** Adjust all totals accordingly in sections 1 to 8, inclusive, of this Act.

**Section 10.** Funds appropriated by this Act which are unspent at the end of fiscal year 2020 may be carried over to fiscal year 2021.

**Section 11.** This Act is effective June 29, 2020.
