- 1 FOR AN ACT ENTITLED, An Act to restrict the transfer of certain appropriated money and
- 2 to provide for the redistribution of certain appropriated money.
- 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF SOUTH DAKOTA:
- 4 Section 1. That § 4-8A-8 be amended to read as follows:
- 5 4-8A-8. Moneys Except as otherwise provided by this Act, moneys appropriated on a
- 6 program basis by the general appropriation act may be transferred between program accounts
- 7 within or between programs within departments and bureaus or between departments and
- 8 bureaus to reflect a reorganization pursuant to S.D. Const., Art. IV, § 8 only at the written
- 9 request of a governing body, department secretary, or bureau commissioner, or designee, in
- accordance with procedures established by the Bureau of Finance and Management and only
- 11 upon written approval of the Bureau of Finance and Management. Transfer of moneys
- appropriated by the general appropriations act between departments, institutions, and bureaus

that is not necessary for a reorganization pursuant to S.D. Const., Art. IV, § 8 may only occur

- 2 at the written request of a governing body, department secretary, or bureau commissioner, or
- 3 designee, only in accordance with procedures established by the Bureau of Finance and
- 4 Management and only upon approval by the special committee created in this chapter. The
- 5 Bureau of Finance and Management shall keep a record of all such authorizations of transfers
- 6 and make them available for public inspection. The bureau shall also submit an informational
- 7 report detailing all transfers approved to the special legislative committee established in
- 8 § 4-8A-2.
- 9 Section 2. That chapter 4-8A be amended by adding thereto a NEW SECTION to read as
- 10 follows:
- Money appropriated as state aid to general education may not be transferred to other
- program accounts. Money appropriated as state aid to general education may be spent only for
- 13 general aid to public school districts.
- Section 3. That chapter 4-8 be amended by adding thereto a NEW SECTION to read as
- 15 follows:
- If the amount of money appropriated as state aid to general education is in excess of the
- amount required to meet the entitlement provided for in chapter 13-13, at such time the excess
- is determined the Department of Education and Cultural Affairs shall distribute the excess to all
- school districts on a pro rata basis according to each school district's adjusted average daily
- 20 membership as defined in § 13-13-10.1.
