1 FOR AN ACT ENTITLED, An Act to adjust the salary schedule for county sheriffs.

2 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF SOUTH DAKOTA:

3 Section 1. That § 7-12-15 be amended to read as follows:

4 7-12-15. The ~~salary payable to a sheriff shall be established by each board of county~~
5 ~~commissioners, by resolution, but may not be less than specified in board of county~~
6 ~~commissioners shall establish, by resolution, the salary payable to the sheriff. The salary payable~~
7 ~~may not be less than~~ the following schedule based upon the most recent decennial federal census
8 of population of counties.

10	Below 9,999 <u>10,000</u>	\$26,299 <u>28,799</u>
11	10,000-16,999 <u>10,000-14,999</u>	28,917 <u>31,417</u>

13	30,000-49,999 <u>25,000-69,999</u>	34,217 <u>36,717</u>
14	50,000 <u>70,000</u> and over	37,590 <u>40,090</u>



1 The board of county commissioners may not decrease the salary of the sheriff during the term
 2 of office of the sheriff. Any sheriff having responsibility for managing a full-time jail shall receive
 3 an additional ten percent added to the base salary listed in this section.

4 Section 2. Section 1 of this Act is effective on January 1, 2003.

5 Section 3. That § 7-12-15 be amended to read as follows:

6 7-12-15. The ~~salary payable to a sheriff shall be established by each board of county~~
 7 ~~commissioners, by resolution, but may not be less than specified in~~ board of county
 8 commissioners shall establish, by resolution, the salary payable to the sheriff. The salary payable
 9 may not be less than the following schedule based upon the most recent decennial federal census
 10 of population of counties.

50,000 <u>70,000</u> and over	37,590 <u>42,590</u>

17 The board of county commissioners may not decrease the salary of the sheriff during the term
 18 of office of the sheriff. Any sheriff having responsibility for managing a full-time jail shall receive
 19 an additional ten percent added to the base salary listed in this section.

20 Section 4. Section 3 of this Act is effective on January 1, 2004.
