The first interim meeting of the Medical Marijuana Oversight Committee was called to order by Senator John Carley at 10:00 a.m. (CT) on Tuesday, August 19, 2025, in Room 413 of the State Capitol, Pierre, South Dakota.

A quorum was determined with the following members answering roll call: Representatives Bobbi Andera, and Josephine Garcia; and Senators John Carley, and Lauren Nelson; and Non-Legislators Francine Arneson (remote), Julie Bostic (remote), Kasey Entwisle, Kristi Palmer, Andrew Schock (remote), Jon Thum (remote), and Pat West.

Staff members present included Anita Thomas, Chief Research and Legal Analyst; Bill Douglas, Fiscal Analyst; Dilyn Tramp, IT Support Specialist; and DeLaney Lewis, Administrative Specialist.
