Notice of Proposed Rules

Department of Transportation: (January 30, 2023) intends to amend rules to make less restrictive the escort vehicle requirements for extra-width vehicles on certain state trunk highways in and around the Black Hills, and to change the approved routes for longer combination vehicles on the state trunk highway system. The general authority for these rules, as cited by the department, is SDCL 32-22-42 and 32-22-42.14.

A public hearing will be held in the Commission Room of the Becker Hansen Building, 700 East Broadway Avenue, Pierre, South Dakota, on February 23, 2023, at 9:00 a.m. (CT). Interested parties may also attend by calling (866) 705-2554 and using conference code 153277. Notices

The **Department of Social Services** is providing additional assurance of compliance with the American Rescue Plan (ARP) Act, per the request of the Center for Medicare and Medicaid Services (CMS). Specifically, this notice addresses a modification to cost sharing with the State Plan Amendment (SPA) 22-0011, which was submitted to CMS on September 9, 2022. The State assures compliance with the ARP Act provision requiring states to cover immunization, testing, and treatment of COVID-19 as well as treatment of a condition that may seriously complicate the treatment of COVID-19 for individuals who are diagnosed with or presumed to have COVID-19, in all service settings, without cost sharing for the beneficiary. The SPA was made effective March 11, 2021, consistent with State Health Official letters issued by the CMS on August 30, 2021, and October 22, 2021. The State will request 1135 waiver authority allowing modification of public notice requirements for post-submission of this notice, which is a condition for the approval of SPA 22-0011. This notice does not alter the original SPA submission documents or associated fiscal impact.

The public comment period will start February 6, 2023, and end March 8, 2023.

The **Department of Social Services** intends to make changes to the South Dakota Medicaid and CHIP State Plans, pursuant to section 9822 of the American Rescue Plan Act. The proposed State Plan Amendments (SPAs) provide an extended postpartum coverage period from 60 days to 12 months to ensure parity between pregnant women and the new adult eligibility group in conjunction with Medicaid Expansion. The agency intends to submit two SPAs to the Center for Medicare and Medicaid Services (CMS) on or before March 1, 2023, as follows: provide 12 months continuous postpartum coverage to beneficiaries who are eligible for and enrolled in Medicaid while pregnant; and provide 12 months continuous postpartum coverage to beneficiaries who are eligible for and enrolled in CHIP while pregnant. In alignment with Medicaid Expansion, the SPAs will have an effective date of July 1, 2023. The department's estimate for the fiscal impact associated with these SPAs is included in the existing projection for Medicaid Expansion as provided in the January 9, 2023, Public Notice which is \$13,943,834 in state funds and \$125,494,504 in federal funds, totaling \$139,438,338 in Federal Fiscal Year 2023, and \$55,775,335 in state funds and \$501,987,015 in federal funds, totaling \$557,753,350 in Federal Fiscal Year 2024.
