South Dakota Investment Council: (May 19, 2023) intends to adopt rules to clarify the South Dakota Investment Council's declaratory ruling process and repeal unnecessary rules. The general authority for these rules, as cited by the council, is SDCL 1-26-15, 4-5-28, 13-63-2, 13-63-12, 13-63-21, and 13-63-23.
