### Notice of Proposed Rules

Date in parentheses indicates when rules were filed with the Legislative Research Council. Copies of proposed rules may be obtained for no charge at https://rules.sd.gov or from the agency directly.

<u>Department of Health:</u> (June 12, 2023) intends to amend rules to define the minimum regulations necessary to maintain the health and safety of residents living in assisted living centers; revise language; correct spelling; update references; add the definition of communicable disease; and add the ability for assisted living centers to stock naloxone for emergency use. The general authority for these rules, as cited by the department, is SDCL 34-1-17, 34-12-7, 34-12-13, and 34-22-9.

A public hearing will be held at the Hayes Building Conference Room, 600 East Capitol Avenue, Pierre, South Dakota, on July 12, 2023, at 1:00 p.m. (CT). Copies of the proposed rules may be obtained without charge from the Department of Health, 600 East Capitol Avenue, Pierre, South Dakota 57501 or online at <a href="https://rules.sd.gov">https://rules.sd.gov</a>. Material sent by mail must reach the department by July 24, 2023, to be considered. This hearing is being held in a physically accessible location. Persons with special needs for which the department can make arrangements may call (605) 773-3361 at least 48 hours before the public hearing.

State Board of Finance (Office of the Secretary of State): (June 15, 2023) intends to amend rules to define terms; repeal reimbursement limits for for-hire and private carriers; repeal allowable household moving expenses; repeal the mobile home moving expense allowance; repeal allowable travel pay in addition to moving expenses; repeal allowable storage expenses; repeal the moving allowance for professionals; repeal the authorization required for reimbursement of moving expenses for professionals; repeal requirements for application for moving expenses for professionals; amend return of transit pay allowance; and repeal allowable travel expenses for professionals. The general authority for these rules, as cited by the board, is SDCL 3-9-1, 3-9-2, 3-9-9, and 3-9-11.

A public hearing will be held in the Bear Butte Room, Second Floor, State Capitol, 500 East Capitol Avenue, Pierre, South Dakota, on July 18, 2023, at 2:00 p.m. (CT). Copies of the proposed rules may be obtained without charge from, and written comments may be sent to, State Board of Finance, 500 East Capitol Avenue, Pierre, South Dakota 57501. Written comments may also be emailed to <a href="BOF@state.sd.us">BOF@state.sd.us</a>. Material sent by mail or email must reach the board at least 72 hours prior to the hearing date to be considered. This hearing is being held in a physically accessible location. #### Notice

The **Department of Social Services** intends to make changes to the South Dakota Medicaid State Plan to implement the inflationary rate increases appropriated by the South Dakota Legislature during the 2023 legislative session, effective July 1, 2023. The proposed State Plan Amendment (SPA) also updates the Physician Administered Drug payment

methodology to reflect the current practice of rebasing the drugs to 100 percent of Medicare's Part B Drug and Biologicals Average Sales Price payment file on a quarterly basis. The updated fee schedule will be posted on the department's website at <a href="http://dss.sd.gov/medicaid/providers/feeschedules/dss/">http://dss.sd.gov/medicaid/providers/feeschedules/dss/</a>. South Dakota Medicaid providers should continue to submit claims and bill South Dakota Medicaid as they did prior to July 1, 2023. Fees schedules are the maximum allowable reimbursement amount; per <a href="https://example.com/ARSD-67:16:01:09">ARSD-67:16:01:09</a>, payment for services is limited to the provider's usual and customary charge.

The proposed amendment revises Attachment 4.19-A, pages 1, 5, 7, 8, 10a, and 10b, and Attachment 4.19-B, Introduction page 1, 1a, and 20b. The department intends to make this SPA effective July 1, 2023.

The following services are receiving a 5.0 percent inflationary increase: Instate DRG Inpatient Hospital Services, Instate DRG Exempt Inpatient Hospitals/Hospital Units, and Instate APC Outpatient Hospital Services; Ambulatory Surgical Center Services; Physician Services; Supplies, Orthotics, and Prosthetics; Durable Medical Equipment (not including items subject to Section 1903(i)(27)) of the Social Security Act); Optometric Services; Chiropractic Services; Occupational, Speech, and Physical Therapy; Nutritionists and Dietician Services; Clinic Services; Eyeglasses, Diabetes Self-Management Training; Nurse Midwife Services; Community Transportation; Secure Medical Transportation; Air and Ground Ambulance Transportation; Home Health Agencies; Independent Mental Health Practitioners Services; Nutrition Items; Personal Care Services; Physician Administered Drugs with no Medicare rate; Community Health Worker Services; Child Private Duty Nursing Services not subject to a targeted increase; Disproportionate Share Hospital Payment Pools; and Graduate Medical Education Payment Pools.

The department estimates the total annual aggregate increase in expenditures by service type will be the following: Inpatient Hospital Services - \$10,714,433; Outpatient Hospital Services - \$2,797,451; Physician Services including EPSDT Screenings/Treatment, and Professional Services Provided in a Freestanding Birth Center - \$6,093,552; Dental Services including Orthodontic Services and Dentures - \$8,052,234; Optometric Services - \$147,653; Chiropractic Services - \$49,372; Disproportionate Share Hospital Payments - \$52,519; Graduate Medical Education Payments - \$165,040; and Other Medical Services (Ambulatory Surgical Center Services; Independent Mental Health Practitioners Services; Nutritionists and Dietician Services; Supplies, Orthotics, and Prosthetics; Durable Medical Equipment; Clinic Services; Physical Therapy; Occupational Therapy; Speech, Hearing, or Language Disorder Services; Prosthetic Devices; Eyeglasses; Diabetes Self-Management Training; Nurse Midwife Services; Community Transportation; Secure Medical Transportation;

Air and Ground Ambulance Transportation; Nutrition Items; Home Health Services; Personal Care Services; Child Private Duty Nursing; and Community Health Worker Services) - \$3,094,224.

The total fiscal impact for the combined services associated with this SPA is \$3,160,081 in state funds and \$4,631,539 in federal funds, totaling \$7,791,620 in Federal Fiscal Year 2023, and \$12,640,323 in state funds and \$18,526,155 in federal funds, totaling \$31,166,478 in Federal Fiscal Year 2024.
