Department of Health: (October 25, 2023) intends to amend a rule to add Newborn Hearing Screening to South Dakota's newborn screening panel. The general authority for this rule, as cited by the department, is SDCL [34-24-25](#).

A public hearing will be held at the Public Health Laboratory Large Conference Room, 615 East 4th Street, Pierre, South Dakota, on November 30, 2023, at 1:00 p.m. (CT). Material sent by mail must reach the Department of Health by December 10, 2023, to be considered. Those wishing to testify remotely must register by November 22, 2023, by email to dohcomments@state.sd.us. Witnesses should provide their full name, email address, whom they are representing, and city of residence. This hearing is being held in a physically accessible location.
