Department of Health: Amend a rule to add Newborn Hearing Screening to South Dakota's newborn screening panel; 50 SDR 59, October 30, 2023.

12-5-2023	South Dakota Animal Industry Board (Department of Agriculture and Natural Resources) : Adopt a rule to clarify that sales of retail meat products would occur only when the producing retail store has full control of the sanitation, storage, and transportation of the products until purchased by the consumer; 50 SDR 60, November 6, 2023.
