South Dakota Board of Education Standards (Department of Education): (December 5, 2023) intends to amend rules to make student learning objectives optional; revise outdated timelines; and clarify and update language. The general authority for these rules, as cited by the board, is SDCL [13-3-69](#), [13-42-33](#), and [13-42-34](#).

A public hearing at which persons may present amendments, data, opinions, and arguments for or against the proposed rules will be held at the MacKay Building, First Floor, Library Commons, 800 Governors Drive, Pierre, South Dakota, on January 22, 2024, at 9:00 a.m. (CT).
