South Dakota State Board of Dentistry (Department of Health): (January 3, 2024) intends to adopt rules to address maintenance, timelines, transfer, and destruction of records maintained by dentists and dental entities. The general authority for these rules, as cited by the board, is SDCL [36-6A-14](#).

A public hearing at which persons may present amendments, data, opinions, and arguments for or against the proposed rules will be held at the Drifters Event Center, 325 Hustan Avenue, Fort Pierre, South Dakota, on February 9, 2024, at 10:00 a.m. (CT)/ 9:00 a.m. (MT).
