Notice of Proposed Rules

Department of Health: (February 12, 2024) intends to amend a rule to add X-linked adrenoleukodystrophy (X-ALD) to South Dakota's newborn screening panel. The general authority for this rule, as cited by the department, is SDCL [34-24-25](#).

A public hearing will be held at the Hayes Building, 600 East Capitol Avenue, Pierre, South Dakota, on March 12, 2024, at 1:30 p.m. (CT). Witnesses should provide their full name, email address, whom they are representing, and city of residence. This hearing is being held in a physically accessible location. South Dakota State Fair (Department of Agriculture and Natural Resources): (February 15, 2024) intends to amend rules to change the start date of the State Fair, adding an additional day, and increase admission, parking, and camping fees accordingly to reflect the added day. The general authority for these rules, as cited by the department, is SDCL [1-21-10](#).

A public hearing will be held at the Nordby Exhibit Hall, South Dakota State Fairgrounds, 1060 3rd Street Southwest, Huron, South Dakota, on March 11, 2024, at 9:00 a.m. (CT).
