South Dakota Commission on Gaming (Department of Revenue): (February 22, 2024) intends to amend a rule to add an additional pay level to the TriLux Bonus Blackjack with Super 3 table game. The general authority for the rule, as cited by the Commission, is SDCL [42-7B-7](#).

The general authority for the proposed rules, as cited by the Board, is SDCL [34-26A-5.1](#), [34-26A-33](#), and [36-19-12.1](#).
