Petition for Rules

The **Department of Game, Fish and Parks** on March 6, 2024, served on the Interim Rules Review Committee and interim director of the Legislative Research Council a petition received from an interested person, per [SDCL 1-26-13](#), to revert [ARSD 41:06:01:08.01](#) to its previous language, allowing for unlimited first choice options for deer seasons instead of the current limit of two applications for some lottery deer drawings. The [Game, Fish and Parks Commission](#) reviewed the petition at its March 7, 2024, meeting.

3-11-2024	South Dakota State Fair (Department of Agriculture and Natural Resources) : Amend rules to change the start date of the State Fair, adding an additional day, and increase admission, parking, and camping fees accordingly to reflect the added day; 50 SDR 98, February 20, 2024.
3-12-2024	Department of Health : Amend a rule to add X-linked adrenoleukodystrophy (X-ALD) to South Dakota's newborn screening panel; 50 SDR 98, February 20, 2024.

3-19-2024	South Dakota Commission on Gaming (Department of Revenue) : Amend a rule to add an additional pay level to the TriLux Bonus Blackjack with Super 3 table game; 50 SDR 101, February 26, 2024.
3-25-2024	Department of Health : Amend a rule to correct language to clarify that home health agency personnel and hospice providers are required to be Medicare-certified, not Medicaid-certified; 50 SDR 104, March 4, 2024.
5-8-2024	South Dakota Board of Funeral Service (Department of Health) : Amend rules to reflect changes to statutes during the 2023 and 2024 legislative sessions, the effect of which is to remove unnecessary barriers to licensure, update language to reflect current terminology and practice, and correct legal and authority references; 50 SDR 101, February 26, 2024.
