Notice of Proposed Rules

South Dakota State Board of Dentistry (Department of Health): (April 3, 2024) intends to amend rules to update the collaborative supervision administrative rules and remove a clinical practice requirement to make the rules consistent with [House Bill 1074](#), which was passed by the 2024 Legislature. The general authority for these rules, as cited by the board, is SDCL [36-6A-40.1](#) and [36-6A-40.2](#).

A public hearing at which persons may present amendments, data, opinions, and arguments for or against the proposed rules will be held at the Drifters Event Center, 325 Hustan Avenue, Fort Pierre, South Dakota, on May 31, 2024, at 10:00 a.m. (CT)/ 9:00 a.m. (MT). Copies of the proposed rules may be obtained without charge from, and written comments on the proposed rules may be sent to, the South Dakota State Board of Dentistry, P.O.
