4-30-2024	<u>Department of Human Services</u> : Amend a rule to allow providers of CHOICES waiver services to cease providing services to participants appealing a termination notice after a decision is issued, or ninety days from the date of the termination notice, whichever is sooner; to clarify who may appeal; and clarify what is reviewed during appeal hearings; 50 SDR 115, April 2, 2024.
5-2-2024 NOTE: The initial listing of proposed rules to be considered at this hearing referenced some rules that have	<u>Department of Game, Fish and Parks</u> : (April 11, 2024) intends to amend rules to create consistency in the use of the terms "bull" and "non-trophy"; consider the use of archery equipment during the Custer State Park trophy and non-trophy bison harvest season; modify the allowable hunting days and number of licenses for trophy bison; modify the dates for grouse, quail, and partridge hunting seasons; modify the word "common" in the rule for a snipe hunting season and set guidelines for daily bag and possession limits; modify the cottontail rabbit hunting season on publicly accessible land; modify the tree squirrel hunting season; and modify the number of non-trophy bison licenses; 50 SDR 122, April 15, 2024.

5-31-2024	<u>South Dakota State Board of Dentistry (Department of Health):</u> Amend rules to update the collaborative supervision administrative rules and remove a clinical practice requirement to make the rules consistent with <u>House Bill 1074</u> , which was passed by the 2024 Legislature; 50 SDR 118, April 8, 2024.
