## SCHEDULED PUBLIC HEARINGS

---

<b>7-19-2024</b>	<b><u>Department of Health:</u></b> Repeal rules related to the regulation of emergency medical responders (EMRs) and emergency medical technicians (EMTs) as regulation of EMRs and EMTs is being transferred from the Department of Health to the Board of Medical and Osteopathic Examiners. The rules also update language related to ambulance services including changing the deadline for ambulance services to submit required electronic patient care reports from monthly to within seventy-two hours of completion of an ambulance run; establishing a process for ambulance services to request a hardship exemption for the medical director requirement; and establishing quality assurance standards for advanced life support ambulance services; 51 SDR 2, July 1, 2024.
<b>7-23-2024</b>	<b><u>South Dakota Electrical Commission (Department of Labor and Regulation):</u></b> Amend rules to adopt the 2023 National Electrical Code (NEC); implement standards for the approval and management of third-party inspectors; apply the statutory minimum inspection fee of one hundred dollars under SDCL 36-16-30; and formalize the third-party inspector process; 50 SDR 142, May 28, 2024.
<b>7-29-2024</b>	<b><u>Department of Health:</u></b> Amend a rule to increase the fee for medical cannabis establishments, per Senate Bill 43 which was passed by the 2024 South Dakota Legislature; 51 SDR 1, July 1, 2024.
<b>7-29-2024</b>	<b><u>South Dakota Division of Insurance (Department of Labor and Regulation):</u></b> Amend rules to implement an examination validity program and maintaining qualifications program for eligible broker-dealer agents, investment advisers, and investment adviser representatives, and update the examination requirement for investment advisers and investment adviser representatives; 51 SDR 5, July 8, 2024.
<b>8-1-2024</b>	<b><u>Division of Labor and Management (Department of Labor and Regulation):</u></b> Amend rules to update the source of the reference used to calculate reimbursement rates for providers of workers' compensation dental procedures to the 2023 edition and increase the conversion factor for dental fees; 51 SDR 2, July 1, 2024.
<b>8-16-2024</b>	<b><u>South Dakota Board of Podiatry Examiners (Department of Health):</u></b> Amend a rule to update the renewal fees to ensure financial viability of the board; 50 SDR 137, May 20, 2024.
<b>8-20-2024</b>	<b><u>South Dakota Board of Physical Therapy (Department of Health):</u></b> Amend rules to update the activities that meet continuing education requirements and update the waiver of continuing education requirements; 50 SDR 142, May 28, 2024.
