Petition for Rules

The **Department of Transportation** on July 22, 2024, served on the Interim Rules Review Committee and the director of the Legislative Research Council a petition received from an interested person, per <u>SDCL 1-26-13</u>, to adopt administrative rules relating to the speed limits on U.S. Highway 81 in and around its intersection with U.S. Highway 18 in Hutchinson County and S.D. Highway 37 in and around its intersection with S.D. Highway 46 in Bon Homme County. Joel Jundt, Secretary, Department of Transportation, on July 15, 2024, denied the petition as the department is planning to install all-way stop signs at these intersections as part of a highway improvement project planned for construction next spring.

Executive Order

Governor Noem has signed <u>Executive Order 2024-06</u>, dated July 26, 2024, pursuant to Chapter SDCL <u>34-48A</u>, declaring a state of disaster to exist in the following counties: Aurora, Bennett, Bon Homme, Brule, Buffalo, Charles Mix, Clay, Davison, Douglas, Gregory, Hand, Hanson, Hutchinson, Jackson, Lake, Lincoln, McCook, Miner, Minnehaha, Moody, Sanborn, Tripp, Turner, Union, and Yankton. The Order is in response to recent severe storms, heavy rainfall, flooding, and straight line winds in the state which caused significant damage to utility and road infrastructure; unexpected costs for debris removal and road repairs; damage to homes and businesses; and interruptions to the normal flow of emergency services, mail, and commerce. The Order, which does not have an end date, also declared that federal resources "are needed to help alleviate the impacts of severe storms, heavy rainfall, flooding, and straight line winds for local governments in South Dakota."
