South Dakota Board of Medical and Osteopathic Examiners (Department of Health): (September 4, 2024) intends to amend, repeal, and adopt rules providing for the regulation and oversight of all emergency medical service personnel under the Board of Medical and Osteopathic Examiners as a result of the passage of Senate Bill 63 and Senate Bill 64 by the 2024 South Dakota Legislature.
