| 10-7-2024 | <u>South Dakota Board of Medical and Osteopathic Examiners (Department of Health)</u> : Amend, repeal, and adopt rules providing for the regulation and oversight of all emergency medical service personnel under the Board of Medical and Osteopathic Examiners as a result of the passage of <u>Senate Bill 63</u> and <u>Senate Bill 64</u> by the 2024 South Dakota Legislature; 51 SDR 31, September 9, 2024. |
| 10-11-2024 | <u>Board of Technical Professions (Department of Labor and Regulation)</u> : Amend rules to update board meeting scheduling guidelines and board member duties; modernize language to allow certain records, state-specific exams, and notices to be stored and transmitted in an electronic format; update the ARE test score validity policy to match NCARB policy, including the elimination of the NCARB "rolling clock" policy; eliminate the use of professional titles by retirees; update the experience and educational requirements for certain types of applications; eliminate fees for duplicate licenses obtained directly through an online portal; repeal board rules regarding disciplinary proceedings; update selected rules with clearer language and provide clear timelines; remove as precondition to taking certain exams, the requirement that an applicant complete the relevant experience requirement (also called "decoupling"); and eliminate the alternative continuing professional development option for architects; 51 SDR 40, September 23, 2024. |
