FILINGS WITH THE LEGISLATIVE RESEARCH COUNCIL

Petition for Rules

The **Department of Game, Fish and Parks** on October 15, 2024, served on the Interim Rules Review Committee and the director of the Legislative Research Council, petitions received from interested persons, per [SDCL 1-26-13](#), to establish an administrative rule implementing a one hundred dollar bounty on coyotes, and repeal ARSD [41:08:01:12](#) which sets certain nonresident restrictions on the taking of beaver, bobcat, mink, muskrat, raccoon, and weasel out of season. The [Game, Fish and Parks Commission](#) will review the petitions at its November 7, 2024, meeting.

Notice

The **Department of Social Services** intends to amend the South Dakota Medicaid State Plan regarding Doula Services. The proposed state plan amendment (SPA) proposes to implement coverage and reimbursement for pregnancy-related doula services including prenatal, labor, and delivery, and postpartum supports. Services will be provided by qualified individuals with double certifications from programs approved by South Dakota Medicaid. Payment for doula services is limited to the lesser of the provider's usual and customary charge or the fee contained on South Dakota Medicaid's fee schedule as shown below:

Code	Description	Fee
T1032	Prenatal, postpartum, or care coordination services (15 minutes/unit)	\$16.86
T1033	Labor and delivery services	\$600.00

The SPA adds page 26d to Supplement to Attachment 3.1-A, and amends Introduction Page 1 and page 26 of Attachment 4.19-B to the South Dakota Medicaid State Plan.

The department intends to make this SPA effective January 1, 2025, and estimates the fiscal impact will be \$50,984 in state funds and \$75,413 in federal funds, totaling \$127,397, in Federal Fiscal Year 2025, and \$67,979 in state funds and \$101,884 in federal funds, totaling \$167,863, in Federal Fiscal Year 2026.
