## FILINGS WITH THE LEGISLATIVE RESEARCH COUNCIL

#### Petition for Rules

The **South Dakota State Board of Dentistry (Department of Health)** on October 30, 2024, served on the Interim Rules Review Committee and the director of the Legislative Research Council, a report on the final action taken on petitions received from interested persons, per <u>SDCL 1-26-13</u>. At its October 18, 2024, meeting, the <u>South Dakota State Board of Dentistry</u> denied the petitions which sought to add new sections to Article <u>20:43</u> to allow dental hygienists and registered dental assistants to perform limited restorative functions and allow registered dental assistants to perform supragingival scaling; and amend ARSD <u>20:43:09:06</u> to allow dental assistants to administer nitrous oxide and monitor patients under nitrous oxide.
