Petition for Rules

The **Department of Game, Fish and Parks** on December 2-3, 2024, served on the Interim Rules Review Committee and the director of the Legislative Research Council, petitions received from interested persons, per [SDCL 1-26-13](#), to establish an administrative rule requiring all licensed big game hunters to submit a harvest report to the department, and to amend ARSD [41:07:05:02](#) to allow South Dakota residents who have a Gavins Point paddlefish snagging permit to snag paddlefish beyond the mouth of the James River up to the Highway 50 bridge. The [Game, Fish and Parks Commission](#) was scheduled to review the petitions at its December 5, 2024, meeting.
