Notice of Holiday Hours

Petition for Rules

The **Department of Game, Fish and Parks** on December 20, 2024, served on the Interim Rules Review Committee and the director of the Legislative Research Council, reports on the final action taken on petitions received from interested persons, per [SDCL 1-26-13](#). At its November 7, 2024, meeting, the [Game, Fish and Parks Commission](#) denied petitions which sought to establish an administrative rule implementing a one hundred dollar bounty on coyotes, and repeal ARSD [41:08:01:12](#) which sets certain nonresident restrictions on the taking of beaver, bobcat, mink, muskrat, raccoon, and weasel out of season. In action taken at its December 5, 2024, meeting, the Commission denied petitions requesting to establish an administrative rule requiring all licensed big game hunters to submit a harvest report to the department, and to amend ARSD [41:07:05:02](#) to allow South Dakota residents who have a Gavins Point paddlefish snagging permit to snag paddlefish beyond the mouth of the James River up to the Highway 50 bridge.
